After the club election in January, the treasurer will register the officers with Sun Biz (as required by the State of Florida Corporations).

Balance Sheet for the year was presented to the Board of Directors

A Yearly update from the club's Paypal account was give.

**Awning Bid** of \$2654 was awarded to American Awning. One half of the contract has been paid. Balance due upon completion. Awning to be installed in January 2018.

**Roof Leak.** The roof has been fixed. Some screws had loosened, thereby letting water come in.

**Drywall Repair.** Jensen Drywall will be fixing both sides of the damage ceiling and getting rid of the gap over the door provided the door can still be opened.

**Access Card Eligibility:** Motion to rescind the six-month waiting period for a new member to be eligible for an access card. Effective January 1, 2018. Motion made by Celeste Platte. Seconded by Fran Smith. Approved unanimously.

**Payment for Classes:** The Board discussed payment of classes using a check. There is a great deal of paperwork involved with the acceptance of checks. Frequently checks are not received in a timely manner to assure that the class has the required number of participants. To streamline the registration process, the following motion was made. Motion: Effective January 1, 2018, only on-line payments will be accepted for class registration. Motion made by Celeste Platte. Seconded by Nancy Honchar. Unanimously approved.

MOTION 1

Motion to rescind the motion of 5/24/17 allowing members to purchase an access card without the required volunteer hours. Motion made by Celeste Platte Second by Lieselotte Hookey. Motion passed by majority. Diane Wolak did not vote.

MOTION 2

Motion to modify the approved motion of 12/18/17 to read:

Motion to rescind the six-month waiting period for a new member to be eligible for an access card effective January 1, 2018. In order to purchase or renew an access card, the member MUST have accrued 20 hours of volunteer time within the previous 12 months (not calendar year) or taught three regular classes (with or without compensation).

Volunteer hours and/or three regular classes taught will be the only criteria used to purchase an access card.
