Electronic, telephone, or unsigned entries **CANNOT BE ACCEPTED**. Entries must be presented on an official entry form including the signature page on the reverse side. No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance. Acknowledgment of entries will be made as soon as possible. Owners are responsible for errors in making out entry forms, and no entry fee will be refunded in the event of such errors or cancellation of entries after the published closing date. Entry Fees shall not be refunded in the event that: a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Show Committee; or, the Trials cannot be held or completed by reason of riots, civil disturbance, fire, flood, disaster, Act of God, public emergency, act of public enemy, strikes, or any other case beyond the control of **OTCPBC**.

If a female is withdrawn from competition because it came into season, and the event secretary is notified no later than one half hour prior to the start of the first class in the trial, the entry fee will be refunded, minus a processing fee of \$5 per dog per day. The Trial Committee will convene as a result of any damage to hotel, motel, trial premises or on complaints of abusiveness to judges, stewards, workers or dogs. All exhibitors are kindly requested to assist in maintaining the cleanliness of the facility and the grounds or hotels.
