ENTRY DRAWING: At 9:00 AM December 31, 2018 the Secretary will conduct a random draw of all entries at 9437 Rodeo Dr, lake Worth, FL 33467. There will be a separate draw conducted for the AKC Worker Option. Based on the number of tracks offered at this test, there will be one track available for the Worker Option for 3-5 VST. Immediately after the Worker Option draw another draw will be conducted to determine the remaining entries. When the limit of 8 dogs has been reached, all remaining entries will comprise the alternate list. Alternates have the option to accept or decline being placed on the alternate list. Those that decline will have their entry fee and certifications, if applicable, returned. The Test Secretary will notify all entries of the draw results.

DRAW FOR TRACKS: 7:15 AM January 6, 2019 in the Mirasol Publix parking lot, 6251 PGA Blvd, Palm Beach Gardens, FL 33418. In the event an accepted entry is absent at the draw, the judges shall mark the dog "Absent" if an Alternate is present to draw. The Alternates that are present will be selected to draw by the order on the Alternate's List. If there are no Alternates present, the judges may designate the Test Secretary to draw for the Absent dog. If the Test Secretary has drawn for the absent dog, the dog will be marked absent if it is not present for the running of their track.

ELIGIBILITY

ELIGIBILITY FOR VST TEST: The Variable Surface Tracking Dog test shall be for dogs that have earned the TD or TDU Title. A dog may continue to participate in this test after it has earned the title VST. However, the Tracking Test Secretary shall give dogs not holding a VST title priority for entry in the test.

ELIGIBILITY FOR TDU TEST: The Tracking Dog Urban test shall be for non-TDU titled dogs and dogs that have earned the TD, TDX, VST, or TDU Title. A dog may continue to participate in this test after it has earned the title TDU. However, the Tracking Test Secretary shall give dogs not holding any of the above titles priority for entry in the test. With the entry of a non-TD/TDU titled dog, there must be included an original statement (certification) dated not more than one year prior to the test date, signed by an AKC Tracking Judge, stating that the dog is considered to be ready for the Tracking Dog Urban Test.

Additional information

BITCHES IN SEASON MAY PARTICIPATE: Entrants must notify the Test Secretary and Judges that their Bitch is in season prior to the drawing for tracks. Bitches in season will participate only after all other dogs have been run.

AWARDS: Those dogs marked "PASSED" will receive the final article signed by the judges and tracklayer, a new title rosette and they will be issued a certificate by the AKC.
