Entries: \$23 for the first entry of each dog (includes \$3.50 AKC recording fee), \$12 for second entry of same dog on same day (includes \$3 AKC recording fee), \$12 for third entry of same dog on same day accepted by mail or in person until 6:00 PM Saturday, February 4th, 2012.

AWARD INFORMATION

Placement rosettes will be given for 1st through 4th place in each jump height in each class. Dark green qualifying ribbons will be awarded to all dogs receiving a qualifying score. Rosettes and ribbons will only be awarded for qualifying scores. The Club reserves the right to substitute prizes of equal or greater value. All prizes must be claimed the day of the trial—none will be mailed.

NOTICE TO EXHIBITORS

Telegraph, telephone and fax entries cannot be accepted. Entries not on Official AKC Entry Forms or Entry forms without the Agreement and Rules on the reverse side of the form are not acceptable. Unsigned Entry Forms cannot be accepted nor entries which specify any conditions as to its acceptance. Entry Forms MUST be filled out completely. Incomplete entries do not constitute a valid entry.

Owners are responsible for errors in making out entry forms, whoever may make such errors, & no entry will be refunded in event of such errors or cancellation of entries after published closing date. PLEASE PRINT OR TYPE CLEARLY.

Obedience Club of Palm Beach County, the trial secretary, their agents, etc., assume no responsibility for any loss, damage, or injury sustained by exhibitors or their dogs or property, and further assume no responsibility for injury to children not under the control of their parents or guardians.

IF IT IS NECESSARY TO RESCUE A DOG from a parked car on the show grounds, the Club will not be responsible or liable for any damage to the car involved.

Owners or handlers entering dogs in a trial do so at their own risk and agree to assume responsibility for any damage caused by them, or by their dogs. They also agree to abide by the Rules of the American Kennel Club and the current edition of the AKC Agility Regulations.

The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all the obstacles safely.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such cases, no refund of any fees paid will be made.

ENTRY REQUIREMENTS

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), **an AKC Canine Partners listing number**, or approved Foundation Stock Service (FSS) breeds are eligible to participate, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of breeds that may participate.

MAXIMUM ENTRIES PER ENVELOPE

A maximum of 10 entries per envelope is allowed. Envelopes with more than 10 entries and/or entries received prior to the opening date will be returned.

MOVE UPS

Written requests for dogs to be moved-up to a higher class, as a result of qualifying for an agility title, will be accepted at the trial secretary's address until 6:00 pm on Monday, February 11th, 2013 and will be included in the running order. Day-to-day move-ups will be accepted day to day but must be into the Trial Secretary no later than the close of the preceding day's trial.

FIRST RECEIVED, HAND DELIVERY

Paper entries received within 24 hrs of the opening date and time must: 1) include postage or be metered; 2) be delivered by a multi-state or multi-national postal or carrier service, including but not limited to USPS, FedEx, UPS and DHL. If above conditions are not met, the entries are not valid and must be returned to the sender.

REFUNDS

Entry fee minus \$15.00 per day entered will be refunded for bitches that come in season after the close of the trial. The Trial Secretary must receive written notification by 9:00 am the day of the trial. Entry fee will not be refunded in the event that the dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee or if the trial cannot open or be completed by reason of civil disturbances, fire, or any other cause beyond the control of the organizing committee. A \$20.00 service fee will be assessed to all returned checks.

SITE INFORMATION

All classes will be held under cover on clay in rings of approximately 100 x 100. There is plenty of crating space under cover. **NO CRATE Set up is allowed until the rings are finished on Friday morning.** Crates may be left overnight, but exhibitors do so at their own risk. We will be using Electronic Timing.

FOOD AND VENDORS

Please note: Due to the Town of Davie's contractual obligations with its vendors, **competitors are prohibited from bringing coolers, food or drink onto the arena property.** This regulation will be strictly enforced. Food concessions are available on site and several fast food establishments and restaurants are nearby on Davie Road. Picnic lunch/tailgating is permitted in the parking lots and competitors are permitted to bring containers of water/treats for their dogs. OTCPCB will provide meals for our volunteer workers.

RV PARKING

Complimentary motor home/RV overnight parking will be allowed in the East lot across from the arena, however, no electric or water hookups will be available and there is no official registration. Parking is first come first serve. PLEASE, no roping off or saving spots.

COURSE FAMILIARIZATION AND WARM-UPS

The walk-through is restricted to handlers entered only in that class.

NEW Simplified Jump Height Card Process

When filling out the entry form, there is a new section at the top of the form for exhibitors to designate whether your dog needs to be officially measured. Please check the box so that the Trial Secretary knows whether to include your dog on the *Dogs To Be Measured List*. It is no

longer required that you submit a copy of your dog's jump height card with your entry form or show it during day of show check-in.

Handlers may opt to enter in a higher height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine PartnersSM program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
