Obedience Entry Fees: Includes \$3.00 for AKC event service and recording fees. \$23.00 first entry EACH DAY regular class. \$15.00 for each additional entry of the same dog, same day (AKC Rule, Chapter 15, Section 2).

Rally Entry Fees: Includes \$3.00 for AKC event service and recording fees for EACH Rally Entry. \$23.00 for each entry EACH DAY, \$15.00 for each additional entry of the same dog, same day (AKC Rule, Chapter 15, Section 2).

Non-Regular Entry Fees: AKC event services fees not assessed. \$15.00 for each entry, regardless of number or non-regular entries per dog.

Bitches That Come Into Season, after the closing date of entries, may have the entry fee refunded, less \$5.00 - upon written request from the owner or handler on or before date of trial.

Dogs Should Be Present at least one-half hour before they are to be judged. The owner or handler is solely responsible for having their dog at the ringside when it is due in the ring. Dogs not required for further judging may be excused.

2-Day Trial Catalogs will be available on the day of the trial for \$3.00 per catalog.

Crating Area is limited. X-Pens and personal floor mats will not be permitted at the trial site. Upstairs crating will be available.
