Exhibitors should follow their veterinarian's recommendation to ensure their dogs are free of internal and external parasites and any communicable diseases and are appropriately vaccinated.

### **Test Site Information**

***Dogs must remain in their crates or cars until tested. There is no inside crating at the facility. Please utilize the pea gravel area or public space along Gateway Road for pet elimination. Do not soil on the lawns and shrubberies of the neighborhood.***

All dogs must be on a 6' leash at all times when not being tested. No flexi-leashes for walking dogs on test site grounds; Flexis may be used in the test itself.

### **Entry Requirements**

The handler of the dog must be a current member of the NACSW™. The Dog must be registered with the NACSW™. For information on how to register or become a member, go to [www.NACSW.net](http://www.NACSW.net)

### **Trial Eligibility and ORTs**

*An ORT must be taken and passed at least 14 days before a trial opening date to be eligible for the first draw period.*

### **Entry Fee and Second Dog Policy**

Fee will be \$35.00 per dog/per odor  
There is a two dog maximum per handler per odor tested

### **Closing Date**

Entries and payments must be received at the Secretary's address by December 30, 2015  
Overnight mail entries must have the signature request waived.

### **Refund Policy**

Cancellations made on or before December 30, 2015 by 5:00 PM will be refunded minus a \$10 administrative fee. No refunds after the entry closing date. Cancellations may be made by e-mail to: [mcpartlandjudy@gmail.com](mailto:mcpartlandjudy@gmail.com)

**ENTRY FEES** shall not be refunded in the event that a dog is absent, disqualified, or excused by the NACSW™ official or judge.

### **Video/Photography Policy**

ORT participants are allowed to have a friend or family member video/photograph their test. ORT participants are not allowed to video/photograph one another. ORT hosts are not obligated to provide someone to video/photograph.

**For GPS Directions:** 1250 Gateway Road, Lake Park, FL 33403

**From I-95:** Take exit # 77 (Northlake Blvd.) go East to Old Dixie Hwy (Speedway station on right [SW corner]). Turn right on Old Dixie Hwy and turn right at the 3<sup>rd</sup> street on right (Gateway Rd.). Proceed to the end of Gateway Road. **OTCPBC is the last building on the left.**

**From the FL Turnpike:** Take exit # 107 (Beeline Hwy. NEED SUNPASS) turn right after exit. Go to 1st light Northlake Blvd, turn right (East). Turn right on Old Dixie Hwy (Speedway station on right [SW corner]). Turn right on Old Dixie Hwy and turn right at the 3<sup>rd</sup> street on right (Gateway Rd.). Proceed to the end of Gateway Road. **OTCPBC is the last building on the left.**

## **TEST Information - Notice to Exhibitors**

**THE TEST SITE** will be open from **7:30 AM-5:00 PM**

**CHECK-IN:** Details regarding check in time and briefing will be sent approximately 1 week before the ORT.

**HANDLER BRIEFING: 8:30 AM**

**An ORT must be taken and passed at least 14 days before a trial opening date to be eligible for the first draw period.**

**Score books are optional and are not required to participate in an ORT.** They are for personal record keeping. If you have lost a scorebook or would like a replacement, you can request a replacement score book that will include all your prior NACSW results. Log in to your account at: <http://www.nacsw.net> and under the "My Account" section, go to "My Dogs" and choose the option to order a replacement score book there. The cost is \$20.

**NO SPECTATORS ARE PERMITTED IN THE SEARCH AREA** during the ORT except NACSW™ officials, adults accompanying a minor, CNWI-in-training, or immediate family members/friends of the dog/handler team currently being tested.

### **ENTRIES:**

- TELEPHONE, FAX, UNSIGNED ENTRIES, AND ENTRIES RECEIVED WITHOUT FEES cannot be accepted.
- RETURNED CHECKS do not constitute a valid entry fee. A charge of \$25.00 will be made for each returned check.
- ENTRIES MUST BE MADE ON THE ATTACHED ENTRY FORM.
- NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED, WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE.
- OWNERS are responsible for errors in making out entry forms.
- EXPRESS MAIL entries must include signature permitting them to be left at the secretary's address without recipient's signature.

**DOGS PRESENT** will not be permitted to roam. Exhibitors are responsible for the behavior of their dogs. The owner of each dog is solely responsible for having it ready when it is to be judged. Be prepared to keep your dog in your car when not being tested or on leash at all times. There is no inside crating at this test.

**FEMALES IN SEASON – Contact your test host at least 1 day before the ORT if this becomes a possibility.**

**DOGS PARTICIPATING** in ORT must be at least six months of age and must appear to be healthy on trial day and should be current on all vaccinations required by law.

**Acknowledgement of entry acceptance/CONFIRMATION** will be made when entries are processed for those handlers that provide an email address. If you require a confirmation via USPS, you must provide a self-addressed stamped envelope with your entry.

**BASIC DESCRIPTION OF TEST** – to successfully pass an ORT a dog must identify the location of the target odor and the handler must correctly call an "alert" within a three-minute time period. The Odor Recognition Test consists of a drill type exercise which requires 12 closed boxes set up in a pattern of one or two rows spaced a minimum of 48" apart. The ORT is conducted on leash. Complete information can be obtained on the NACSW™ website.
