## Benadryl for Dogs

The temptation to reach into our medicine cabinets to treat our pets can be very dangerous. Humans and dogs react very differently to medications, which is why veterinarians caution dog owners against making independent decisions about how to medicate their animals. However, some human medications are safe for use with dogs, as long as they are used appropriately.

Veterinarians use Benadryl for dogs on a regular basis to <u>treat allergies</u>, <u>travel anxiety</u>, and motion sickness. While you should always consult with your veterinarian before giving your dog a human medication, here is what you need to know about using Benadryl for dogs.

#### What is Benadryl?

Benadryl is the brand name for the <u>active ingredient diphenhydramine HCL</u>. Diphenhydramine is a first-generation ethanolamine-derivative antihistamine, which is the scientific way of classifying antihistamines that can cross the blood-brain barrier from those that cannot. The ability to cross the blood-brain barrier makes them very effective, but also increases the risk of adverse effects when compared to less effective second-generation antihistamines. While <u>Benadryl is not yet FDA-approved for veterinary use</u>, it is considered safe for use in dogs and cats and is commonly used in veterinary practices across the U.S.

### How Does Benadryl Work?

Diphenhydramine is a receptor antagonist, which means that the drug works by blocking the receptors that receive histamines in the body. This relieves many of the symptoms associated with allergies, like itching, sneezing, and hives. The body still produces histamines, but the receptor antagonist blocks the receptors from registering the histamines. It is a bit like the mail-person trying to deliver mail to an already full mailbox. The letter arrives, but there is no room for it.

#### What Does Benadryl Treat in Dogs?

Benadryl is a great medication for use in dogs with mild-to-moderate allergies. Seasonal allergies, food allergies, environmental allergies, and <u>allergic reactions to snake and insect bites</u> all respond to Benadryl in most cases. Benadryl is commonly used to treat itchiness in dogs caused by <u>skin allergies</u>, and it also reduces many of the other <u>symptoms of allergies</u>, including:

Itching

Hives

Swelling and inflammation

Redness

Runny nose and eyes

Coughing

Sneezing

Anaphylactic reaction

One of the side effects of Benadryl is drowsiness, which helps to calm anxious dogs. The Merck Veterinary Manual states that diphenhydramine may relieve symptoms of mild-to-moderate <u>anxiety in pets associated with travel</u>. It also may help relieve motion sickness during car rides and plane rides.

Veterinarians prescribe <u>Benadryl for dogs with mast cell tumors</u> to help mitigate the effects of the massive histamine release caused by mast cell degranulation. Benadryl is also used as adjunct therapy for other conditions. Veterinarians sometimes prescribe diphenhydramine during heartworm treatment, as it helps prevent allergic reactions associated with <u>heartworm treatment therapy</u>.

Benadryl makes an excellent addition to your pet emergency kit. If you don't already have a <u>pet emergency kit or pet travel kit</u>, consider putting one together today.

## **Board of Directors Meeting Thursday, March 2, 2017**

The meeting was called to order 6:20 PM by President Betty Gansky.

Board Members Present: Paige Athan, Celeste Platte, Diane Wolak, Fran Smith, Betty Gansky, Steve Campbell,
Liese Hookey, Nancy Honchar. Guest Presenter: Tracy Guiejka

- A profit was made for the following trials of 2017: Agility February; Obedience January; Nose Work ORT, Nose Work Seminar.
- The premium is now available for the Rally Trials of April 29 & 30, 2017
- The Dusk to Dawn lighting has been completed on building and potty area.
- The Blue Book project Status of Membership Portal is still ongoing, but near completion.
- Membership applications via Website: Potential members will be able to download a membership application. However, they still must obtain signatures from two members who have known them for at least six months. The potential member will also have to bring the application to a general meeting for it to be accepted.
- Membership renewal will be accepted through the OTC website. After discussion by the Board, it was decided
  that the club would absorb the processing fee for membership renewals ONLY. Fran Smith made the above motion. Diane Wolak seconded. Unanimously approved.

#### **NEW BUSINESS:**

- Kitchen remodeling project: Tracy Guiejka obtained three bids from contractors for the remodeling project. She gave a presentation of each of the bids she had researched. After much discussion, the Board asked Tracy to contact one contractor and find out where the cabinets he proposed in his bid were made. Tracy will also contact another contractor and determine if the price quoted could be lowered by using alternative materials than those that were proposed.
- Appliances will be purchased by the club, not the contractor.
- Based on the information Tracy obtains about the cabinets and possible estimate modification, the Board will make a recommendation to the general membership for final approval of the kitchen remodeling.
- The project is expected to last three weeks, but to build in unexpected delays, the project will commence, if approved, after the obedience trial in June.
- Maximum cost would be \$25,000 which includes cabinets, appliances, electrical, sink, granite.
- New letterhead for OTC. Suzie Carlson presented some options for the Board's consideration. Recommendations were made on one of the samples and will be returned to Suzie for modification.
- Event Plans for 2017. Kelly McDonough has agreed to chair the following drives this year. The cereal drive, Canine Cancer, and Toys for Tots.
- Obedience Judges are needed for 2018. Also, if we are going to offer half day of Rally on Friday, we need to make sure the judge will do the classes. Celeste Platte will research available judges with cost efficiency in mind and return the findings to the Board for consideration.
- OTC Fun Day proposed for April by Peggy DeMinico and Lorene Taylor: Betty will contact Peggy and Lorene and ask them for a scenario of what they envision for the fun day. If they want to have the fun day, they must coordinate everything.

Betty made a motion to adjourn. Steve Campbell seconded. Approved. Meeting adjourned at 8:00 PM.
