

#### The American Kennel Club Announces Achiever Dog Certificate Pilot Program

The American Kennel Club is excited to announce the launch of its new Achiever Dog certificate program. The AKC Achiever Dog certificate program is designed to recognize those exhibitors and dogs who participate in multiple sports. A dog will receive an AKC Achiever Dog certificate when they have been awarded a placement or earned a qualifying score in three different sports. Dogs can start earning AKC Achiever Dog certificates December 1, 2017.

"Many exhibitors are interested in participating in different sports," said Dr. Carmen Battaglia, AKC Board Member. "The AKC Achiever Dog program is designed to encourage owners to try a variety of sports, finding those they enjoy and realizing success. Both are winners!"

AKC is launching the Achiever Dog as a pilot program. At the end of one year, all owners who have received a certificate will be surveyed to determine the success of the program. Opportunities for improvement will be identified and could lead to a more refined program which recognizes these versatile dogs. # FDA Warning: Store-Bought 'Bone Treats' Could Kill Your Dog PUBLISHED BY: DogFoodAdvisor

November 28, 2017 — The <u>U.S. Food and Drug Administration has issued a warning</u> regarding the purchase and use of store-bought "bone treats". The FDA claims the danger **goes beyond the risk of regular bones**.



#### What's a 'Bone Treat'?

The FDA reports it has received about 68 reports of pet illnesses related to "bone treats".

**Bone treats** differ from regular uncooked butcher-type bones because they're processed and packaged for sale as "dog treats".

#### Which Products?

A **variety** of commercially-available bone treats for dogs were listed in the reports including **items described as**: "Ham Bones"

"Pork Femur Bones"

"Rib Bones"

"Smokey Knuckle Bones"

No specific brands are mentioned in the FDA bulletin.

The processed products may be dried through a smoking process or by baking. They may also contain other ingredients such as:

Preservatives Seasonings

Smoke flavorings

According to Dr. Carmela Stamper, a veterinarian in the Center for Veterinary Medicine at the FDA...

"Giving your dog a bone treat might lead to an unexpected trip to your veterinarian, a possible emergency surgery, or

even death for your pet."

So, if you're planning to give your dog a stocking full of bone treats this holiday season, you may want to reconsider.

#### Illnesses Reported

Illnesses reported to FDA by owners and veterinarians in dogs that have eaten bone treats have included: Gastrointestinal obstruction (blockage in the digestive tract) Choking Cuts and wounds in the mouth or on the tonsils Vomiting Diarrhea Bleeding from the rectum Death

According to FDA, approximately 15 dogs have reportedly died after eating a bone treat.

#### How Widespread Is the Problem?

To date, reports submitted by pet owners and veterinarians have included about 90 dogs. Some reports included more than one dog.

In addition, FDA has received **7 reports of product problems** such as... Moldy-appearing bones Treats splintering when chewed by the pet

#### How to Keep Your Dog Safe

FDA has included the following tips to help keep your dog safe:

Chicken bones and other bones from the kitchen table can cause injury when chewed by pets, too. So be careful to keep platters out of reach when you're cooking or the family is eating.

Be careful what you put in the trash can. Dogs are notorious for helping themselves to the turkey carcass or steak bones disposed of there.

Talk with your veterinarian about other toys or treats that are most appropriate for your dog. There are many available products made with different materials for dogs to chew on.

#### What to Do?

Dr. Stamper adds the following advice...

"We recommend supervising your dog with any chew toy or treat, especially one she hasn't had before. And if she

'just isn't acting right,' call your veterinarian right away!"

#### AKC Obedience Videos on YouTube

Videos of the two new Novice exercises are available on the AKC Obedience & Rally YouTube channel. The Sit Stay – Get Your Leash and the Group Exercise – Sit and Down Stay, will be performed in the AKC Novice A and B Classes beginning May 1, 2018. These two new exercises will replace the current Novice Group Exercises. The Sit Stay – Get Your Leash will be added to the Preferred Novice class.

#### Novice Obedience Exercises

Videos of the two new Open exercises are available on the AKC Obedience & Rally YouTube channel. The Command Discrimination and Stay – Get Your Leash, will be performed in the AKC Open A, Open B and Preferred Open Classes beginning May 1, 2018. These two new exercises will replace the current Open Group Exercises. The Stay – Get Your Leash will be added to the Graduate Novice class.

### **Command Discrimination Scoring Questions**

#### by <u>Diane Schultz</u>

#### The first change of position is the down. What if the dog stands, and then downs?

If the dog clearly stands, and then downs, he has added a position change that is not according to the Regulations and this would be penalized as an NQ. The first position change for this exercise requires the dog to stand or down from the sit position. The dog is not required to go down in a certain "style." Many dogs raise their hindquarters from a sit to a down, and this would be considered acceptable without penalty. If the movement is continuous, and clearly not an added position, the dog would not be penalized.

#### Is the dog required to be remain in the same heel position after it changes position?

No. A dog changing position, (i.e. sit to a stand, sit to a down) while remaining in place, may end up somewhat out of the starting heel position. The Regulations do not require the dog to remain in heel position. If the dog walked forward, the dog would be penalized for walking forward.

#### Is the handler required to move to heel position before leaving the dog?

No. The Regulations do not require the handler to be in heel position to leave the dog. If the dog walked forward, the dog would be penalized for walking forward.

## What if, when the dog changes position it doesn't remain in heel position, and the handler moves to heel position prior to leaving the dog. Should the handler be penalized?

Not necessarily, it depends. If the handler moves prior to the judge ordering, "Leave your dog," a penalty is not necessary. If the handler moves and then stops in heel position after the judge orders, "Leave your dog," and then leaves the dog, the judge would consider this an additional command/signal to stay which would result in an NQ. (Chapter 2, Section 20 and 21)

RALLY CLOVERLEAF #314

In an effort to provide judges a better understanding of how the Cloverleaf should be used and performed, the description has been revised and will be included in the next printing.

**314. Cloverleaf** - This sign requires the pylons be spaced approximately 6 feet apart. <u>The dog and handler</u> <u>must complete the cloverleaf by crossing the center line four times</u>. The four pylons will be numbered sequentially. The number "1" pylon will be placed to the handlers left, and indicates the entry and exit points for performance of this sign. This is a change of direction sign and upon exiting the team may go in any direction to the next sign.

It is ALWAYS important to read the AKC Rules and Regulations from time to time to remind yourself what is and is not allowed. The regulations even extend to what you can wear in the ring. Also, it is important that you keep your dog under control at all times. Even an attempt by your dog to go after another dog can get you banned from all AKC shows. Know the rules! - Editor

Revisions to the Obedience Regulations

Effective September 1, 2017

This insert is issued as a supplement to the Obedience Regulations amended to January 1, 2016 and approved by the AKC Board of Directors August 8, 2017 Chapter 1. General Regulations Section 10.

"Identification. Club clothing, AKC event clothing, or breed clothing may be worn by anyone exhibiting a dog or by ring stewards. Clothing may display the person's name, the dog's call name and/or the dog's picture. Titles may not be displayed. Writing or graphics on the clothing must not be in poor taste or contain profanity. Clothing must not display any information that would be in conflict with a sponsor of the trial."

A supplement to the Obedience Regulations amended to January 1, 2016 Chapter 1.

General Regulations Section 17. Disqualification, Ineligibility, Excusal, and Change in Appearance of Dogs.

"The judge must excuse a dog that attacks another dog and fill out the required "Dog on Dog Attack" form (AEDSQ3). The owner of any dog that has been excused on two occasions for attacking or attempting to attack another dog will be notified that the dog is no longer eligible to be shown in any AKC event. Such dogs are ineligible to be on the grounds of an AKC event unless and until, following application for reinstatement by the owner to the American Kennel Club, the owner receives official notification in writing from the AKC that the dog's eligibility has been reinstated. The judge must excuse a dog that appears dangerous to other dogs."

The judge's authority now extends outside of the ring.


