#### BOARD OF DIRECTORS MEETING

Obedience Training Club of Palm Beach County (OTCPBC) 1250 Gateway Road, Lake Park, Florida Monday, June 4, 2018

Board Members Present: Betty Gansky, Diane Sedberry, Fran Smith, Liese Hookey, Celeste Platte, Nancy Honchar, Tracey Guziejka, Steve Campbell. Visitor: Judy McPartland

Meeting was called to order at: 5:59 PM by President Betty Gansky.

**Dog Confrontation at Daytona Beach Trial**: Due to a dog confrontation at the recent Daytona Beach Club trial, the OTC Board reviewed options for the club and how to handle a similar situation. An instructional seminar will be offered to instructors, show volunteers as well as anyone interested on how to deal with confrontational dogs at trials. Cheryl Vanvoorhies is experienced in dealing with these types of dogs and offers seminars addressing these concerns. Judy McPartland will contact her to schedule the seminar.

**Treasurer:** Fran Smith gave a report on the club's finances. The banks are starting to question checks made out to OTCPBC, as this is not on the account. The way to avoid future problems is to file a Fictitious Name Affidavit. The Board will have attorney Matthew Taylor, PA file a Fictitious Name Affidavit with all the advertising needed.

Fran proposed moving some of the excess funds from the checking account to a short-term CD. Due to an upcoming roof inspection and possible replacement or major repair, as well as construction to the upstairs loft, the idea will be put on hold at this time

**Nose Work Coordinator**: Judy McPartland announced that Liese Hookey will be chair for the upcoming Nosework trial at OTCPBC.

**Vice President**: Diane Sedberry has spoken to Judge Deb Neufeld about doing a Rally Seminar. She is willing to do it for no charge. She is also willing to drive down and back in the same day. Sunday is the preferred day to schedule the seminar.

**DOCOF**: Bob Millar is willing to coordinate the club's DOCOF team again this year,

**Rally Trial:** The November trial will be limited to 45 dogs per day. Steve Campbell is Chair and Nancy Honchar will be trial secretary.

**Upstairs Storage Area**: Architect Stephen Yeckes has been trying to contact the Lake Park building official for a couple of weeks. He has an appointment on Tuesday June 5. After the meeting, he will contact Tracy about the meeting. Tracy's husband, a retired General Contractor, will review the requirements by the City of Lake Park.

Maintenance Coordinator: Tracy Guziejka has requested a backup person to meet contractors or maintenance people if she is not available at the time needed.

**Minimum Age for the Basic Class**: Betty Gansky asked if the Board needed to set a minimum age for the basic class. The Board felt a case by case should be used and not a minimum age.

**Building Rental Fee Increase:** Motion to charge \$500 (from the current \$350) for the building rental weekend starting January 1, 2019. First Steve Campbell. Second Liese Hookey. Motion passed. Fran Smith and Celeste Platte abstained.

**Miami Obedience Club Rental 2019:** Motion by Fran Smith to allow the Miami Obedience Club to rent the building over memorial weekend 2019 at the higher rate. Second by Steve Campbell. Motion unanimously approved.

**Ring Usage for Agility:** Members can set-up and practice light Agility in the training ring with small items, jumps, a tunnel & weave poles. They also must cede the ring if someone comes in to train in Obedience. REMINDER: Ring time for run thrus is limited to 20 minutes when someone else is waiting. This includes your set up and breakdown time.

**Obedience/Agility Field Use:** On a case by case basis, members with access cards may pay additional to use the field on a month to month basis. Once this fee is no longer paid, it is on an honor system that the member will stop using the field. If any member uses the field without payment, the Board will take appropriate action. It is not the responsibility of the Corresponding Secretary, who collects the fees, to monitor the field's use.

Obedience Training Club of Palm Beach County Board of Director's Meeting, June 20, 2018

Members Present: Betty Gansky, Diane Sedberry, Fran Smith, Celeste Platte, Liese Hookey, Tracey Guziejka. Absent: Steve Campbell, Nancy Honchar

The meeting was called to order by President Betty Gansky at 6:45 PM

The Board of Directors met to review plans to bring the loft into compliance for use by the club. Plans designed by Architect Stephen Yeckes

Items that will need to be constructed/modified:

- Electrical outlets will need to be added every 20 feet to meet code in the loft area.
- Remove the storage closet to accommodate the new stairs
- The ceiling and sprinkler head in the storage closet will need to be raised.
- The stairs will be constructed (or purchased pre-fab) with a landing. This needs to be done to accommodate the pitch required for the stairs to meet code.
- A knee wall will be constructed along the edge of the loft area.
- If clearance from the alcove wall to the first door of the crate room is not sufficient, the door will need to be moved.
- The loft floor may need to be reconstructed or overlaid with lumber. At this time, a load of 100 lbs. per square foot exists in the loft area, but the type of wood used for the flooring is not correct. Until the plans are submitted for a permit, it is unclear what will be required to meet code.

A storage cabinet may need to be purchased and placed in the back part of the building on the opposite side of the roll up door to accommodate cleaning supplies and a few miscellaneous small items. This is NOT a part of the construction plans.



## Entering and Exiting the Ring

by Diane Schultz

It has been a longstanding policy that dogs remain under control when entering and exiting the ring. *The area of the ring gate,* where a team enters and exits the ring, is busy, with people and dogs routinely coming and going. Leaving the ring with a dog under control is not only a display of good sportsmanship but promotes a safer environment for all.

Prior to May 1, 2018, lack of control when exiting the ring often went unnoticed by judges and was not properly penalized under Miscellaneous Penalties.

The additional language that requires a judge to be in position to see the team exit the ring, and to penalize the dog that does not remain under control when they enter and exit the ring, is expected to improve ring safety. It is in no way intended to prevent a team from celebrating joyfully inside the ring between exercises or after the last exercise. The celebration, with the dog remaining under the handler's control, may include and is not limited to jumping for joy, hand touching, spinning, and tugging on the leash inside the ring; however, the dog must exit the ring gate under control and without jumping, tugging, or pulling.


### **VOLUNTEER HOURS**

The volunteer hours through June 20 are on the next pages. Keep in mind that these hours are on an 12 month accrual basis and not a year end basis.

In other words; if you have 25 hours on May 30, 2017 and do not volunteer at all for the next 12 months, on June 1, 2018 those 25 hours will expire and your balance will be zero.

On the other hand, if you volunteer through-out the next 12 months starting on June 1, 2017, the hours before May 30, 2017 will still expire, but all the earned hours after that time will still be in your account. On June 30, 2018 the hours you accrued prior to June 30 2017 will expire, but the hours earned July 1, 2017 forward will be counted.
