The AKC Agility Course Test is an entry level agility event designed to introduce beginning dogs and / or handlers to the exciting sport of agility. Dogs must be 15-months of age or older, physically sound, meet the requirements for a regular AKC agility trial (Chapter 1, Section 3), and may not hold any AKC agility titles, other than an ACT title. Dogs do not need to be registered with AKC to enter, however to receive a title certificate, a non-registered qualifying dog must complete the registration process and will receive instructions on how to do so.

ACT Level 1 is open to all dogs that have not earned any AKC agility titles. The course will have 10-12 obstacles to be completed within a maximum of 60 seconds course time. Obstacles include: 5' A-Frame, table, open tunnels, and bar jumps. Tire and panel jumps may be included. There are no spread jumps (double, triple, or broad jump), teeter, dog walk nor weave poles.

ACT Level 2 is open to all dogs that have not earned an AKC agility title except an ACT1 title. Level 2 courses will have 11-13 obstacles to be completed within a maximum of 70 seconds course time. Obstacles include those from Level 1 plus a teeter, 6-weave poles, tire, and one spread jump (double, triple, or broad jump); the dog walk may also be included.

Earning an ACT Title for either level requires two Qualifying runs with a minimum score of 85. Refusals and run-outs are not judged. More than 3 attempts at an obstacle will result in an elimination (non-qualifying) score. The rest of the faults are the same as in the regular agility classes. All passing scores may be from the same judge.

Dogs may enter any Jump Height division: 4, 8, 12, 16, 20, and 24" at the handler's choice. It is recommended that you enter the height at which you train. An AKC jump height card is not required, and dogs will not be measured at the ACT event. **Dogs may enter both Level 1 and Level 2 in the same Event**.

AWARDS & RIBBONS

Qualifying scores in each class will receive a green qualifying ribbon. Rosettes will be awarded for all teams who earn new titles.

DAY OF SHOW INFORMATION

- Handlers in all rounds will be permitted to walk the course without a dog, during a walkthough period held prior to the start of each round. Judge will give a briefing and course assistance.
- Dogs must be on a leash at all times except when competing.
- There is a potty area across from the building. All owners MUST pick-up after their dogs
- There is limited indoor crating available. Dogs not entered are not permitted. No xpens. No chairs.
- Dogs may arrive to the ACT Event prior to their scheduled time of judging. Dogs not required for further judging will be excused.
- Evaluators will not wait for any dog holding up a Class. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.

NO FLEXI LEADS WILL BE ALLOWED ON THE EVENT GROUNDS OR IN THE BUILDINGS!

NOTICE TO EXHIBITORS

The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all the obstacles safely.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such cases, no refund of any fees paid will be made.
