Inquiries may be directed to Lori Patterson at tsLorip@gmail.com. No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance.

Illegible entries will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry and the Trial Secretary will add a **\$30** collection fee to the amount of each returned check. Obedience Training Club of Palm Beach County is accepting online entries through the AKC Online System. Go to the AKC Agility Online Entry Services home page at www.akc.org/AgilityEntry and follow the instructions there to use your My AKC account to enter this event online. During the first 48 hours after opening, the initial limit of entries designated as either online or paper will be as follows: 100 online entries and 600 paper entries. If either form of entry (paper or online) has not filled at the end of the 48 hour time period, the club reserves the right to decrease or increase either one accordingly.

MEASURING and HEIGHT CARD INFORMATION

Effective January 1, 2010, exhibitors are no longer required to provide proof to Trial Secretaries that their dog has a valid jump height card as part of the check-in process. Furthermore, this change eliminates the need for a copy of the jump height card to be submitted with an entry form. Dogs without a valid Jump Height Card/Form may still compete; but they must be measured/wicketed by the **Judge of Record** PRIOR to running in their class and this measurement will be valid for that weekend of trials only. The exception to this requirement is a dog entered in the 24" height division. However, if a **Volunteer Measuring Official (VMO)** or an **Agility Field Rep** is present; **ALL** dogs without a valid Jump Height Card/Form must be measured at some time during the trial or cluster of trials. This does not preclude having the dog wicketed by the Judge of Record if the VMO or Rep is not available to measure the dog **before** its first run of the trial or cluster of trials. It is the exhibitor's responsibility to have their dog measured prior to running and failure to do so will result in the cancellation of any qualifying scores.

NEW Simplified Jump Height Card Process

When filling out the entry form, there is a new section at the top of the form for exhibitors to designate whether your dog has a valid jump height card or if your dog needs to be measured. Please check the appropriate box so that the Trial Secretary knows whether to include your dog on the *Dogs To Be Measured List*. It is no longer required that you submit a copy of your dog's jump height card with your entry form or show it during day of show check-in.

AWARD INFORMATION

Placement rosettes will be given for 1st through 4th place in each jump height in each class. Dark green qualifying ribbons will be awarded to all dogs receiving a qualifying score. Rosettes and ribbons will only be awarded for qualifying scores. The Club reserves the right to substitute prizes of equal or greater value. All prizes must be claimed the day of the trial—none will be mailed.

MAXIMUM ENTRIES PER ENVELOPE

A maximum of 10 entries per envelope is allowed. Envelopes with more than 10 entries and/or entries received prior to the opening date will be returned.

MIXED HEIGHTS & CLASSES

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend – Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

FEO & FIX N GO

Entering For Exhibition Only (FEO)

FEO allows exhibitors to work with their dogs in a trial environment. FEO is only offered in the Time 2 Beat and FAST classes. Participation in FEO is non-qualifying.

- FEO runs are treated as trial entries. The exhibitor must enter the class(es) (T2B and/or FAST) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master). If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out. FEO may be declared earlier (ex. when checking in at the gate board).
- Toys are allowed in the ring. Toys must be non-audible and may not leave the handlers hand. Toys that roll freely may not be used.
- Food/treats are not allowed in the ring
- FEO should be utilized for the benefit of the dog and not as a punitive correction. Harsh verbal and /or physical corrections shall not be tolerated. Any determination of harshness by the judge shall be immediately whistled and the handler will be dismissed from the ring.
- A judge must monitor the entire run. Judges can stop a run at any time

Fix and Go On

FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score. Fix and Go On is not pre-entered; rather, it occurs during the run.

NOTICE TO EXHIBITORS

Telegraph, telephone and fax entries cannot be accepted. Entries not on Official AKC Entry Forms or Entry forms without the Agreement and Rules on the reverse side of the form are not acceptable. Unsigned Entry Forms cannot be accepted nor entries which specify any conditions as to its acceptance. Entry Forms MUST be filled out completely. Incomplete entries do not constitute a valid entry.

Owners are responsible for errors in making out entry forms, whoever may make such errors, & no entry will be refunded in event of such errors or cancellation of entries after published closing date. PLEASE PRINT OR TYPE CLEARLY. **NO STAPLES OR TAPE PLEASE.**

Obedience Club of Palm Beach County, the trial secretary, their agents, etc., assume no responsibility for any loss, damage, or injury sustained by exhibitors or their dogs or property, and further assume no responsibility for injury to children not under the control of their parents or guardians.

IF IT IS NECESSARY TO RESCUE A DOG from a parked car on the show grounds, the Club will not be responsible or liable for any damage to the car involved.

Owners or handlers entering dogs in a trial do so at their own risk and agree to assume responsibility for any damage caused by them, or by their dogs. They also agree to abide by the Rules of the American Kennel Club and the current edition of the AKC Agility Regulations.

The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all the obstacles safely.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such cases, no refund of any fees paid will be made.

DOGS ELIGIBLE TO ENTER

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under four (4) months of age are strictly prohibited from the trial grounds.

REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. Entry fee will not be refunded in the event that the dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee or if the trial cannot open or be completed by reason of civil disturbances, fire, or any other cause beyond the control of the organizing committee.

Bitches in season will not be admitted to the trial. Any exhibitor with an entered bitch in season, on the trial date, will be refunded the entry fee, less \$5.00 per run (each day), upon written certification from a veterinarian. Notification must be in the hands of the Trial Secretary no later than 30 minutes before the start time on the date of the trial.

COURSE FAMILIARIZATION AND WARM-UPS

The walk-through is restricted to handlers entered only in that class.

MOVE UPS

Written requests for dogs to be moved-up to a higher class, as a result of qualifying for an agility title, will be accepted at the trial secretary's address until **6:00 pm on Monday May 3, 2021** and will be included in the running order. Day-to-day move-ups will be accepted day to day but must be into the Trial Secretary no later than the close of the preceding day's trial.

AFTER CLOSING WAIT LIST

A waiting list will be maintained for these trials once they have closed on April 24, 2021. The waiting list will be active until its deadline - Saturday, May 1, 2021 at 6:00 pm. Any runs that are entered in these trials at closing and pulled before the waiting list deadline will be replaced, if possible, by runs in order on the waiting list, and the exhibitor will be reimbursed for the number of runs replaced. If a run is pulled, but cannot be replaced, the exhibitor will not receive a refund and the dog will be considered absent from the run. Entry fees for runs on the waiting list that do not get into the trial by the waiting list closing date, will be refunded in full.

SITE INFORMATION

Ring size is 88' x 104' on Soccer Turf. We will be using Electronic Timing.

CRATING: is limited. No dogs who are not competing are allowed in the building. No x-pens, lounge chairs or large crate mats allowed. Please stack smaller crates. If you have an RV, please crate your dogs in your RV.

Bratty Paws Dog Plex is a **SMOKE FREE PROPERTY**.

Any dog soiling the turf, the handler will be imposed a \$10 fee. Please potty dogs away the building and do not let dogs go to the bathroom on the landscaping.

The building will be open at 7am on **SATURDAY for crate set-up**. No crate set-up on Friday.
