BE SURE TO INCLUDE ONE WITH YOUR ENTRIES

PER THE AMERICAN KENNEL CLUB

“The two-judge requirement to title in the obedience and rally lower level classes was temporarily suspended as of July 2, 2020. . . . This recommendation was approved to continue the waiver through December 31, 2021.”

In other words, you can earn all three qualifying scores for your title under the same judge.

New safety procedures

- The wearing of a **MASK**/bandana while in the building, will be stated in the Judging Schedule. You are responsible for providing the mask.
- Masks **WILL NOT** be required in the show ring.
- You will be asked to socially distance from all other attendees (as well as their dogs) and **enter the building one at a time** at the time of the scheduled class.
- **Social Distancing** must be utilized at all times on the premises.
- While **OUTDOORS** AND 6’ apart masks are not required.
- **PLEASE DO NOT ATTEND IF YOU FEEL UNWELL.**
- Only the dog handler should attend, no spouses/children/observers unless required for ADA assistance.
- Please bring your dog’s crate inside and get it set up **prior** to bringing your dog into the building.
- Please bring your own crate and chair.
- Please bring your own hand sanitizer or gloves if desired.
- The trial secretary will create a schedule to allow for participants to arrive for their class, show, and leave the premises with minimal contact with other classes. This schedule will be sent at trial closing as it depends upon entry numbers.

NOTICE TO EXHIBITORS:

Regular & Optional Titling Classes: Entry fee for these classes shall be \$27.00 per dog for the **FIRST** entry. (\$17.00 for a second entry of the **SAME DOG** in the **SAME** trial). **RETURNED Checks will be charged a \$25 return check fee.**

Injuries - Dogs that cannot compete due to an injury will be given a refund minus \$5.00 per trial per entry if the trial has already closed. **A written vet letter must be given to the Trial Secretary no later than 30 minutes before the start time on the date of the trial.** Bitches that come into season will also receive a refund as stated above minus a vet letter. If the trial has not closed, a full refund will be given.

Overnight deliveries must be sent with no signature required at delivery.

Entry fees include \$3.50 event service fee paid to AKC.

Electronic, telephone, or unsigned entries **CANNOT BE ACCEPTED**. Entries must be presented on an official entry form including the signature page on the reverse side. No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance. Acknowledgment of entries will be made as soon as possible. Owners are responsible for errors in making out entry forms, and no entry fee will be refunded in the event of such errors or cancellation of entries after the published closing date. Entry Fees shall not be refunded in the event that: a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Show Committee; or, the Trials cannot be held or completed by reason of riots, civil disturbance, fire, flood, disaster, Act of God, public emergency, act of public enemy, strikes, or any other case beyond the control of **OTCPBC**.

Full refund can be requested prior to trial closing date and request must be made in writing (email is acceptable). If a female is withdrawn from competition because it came into season, and the event secretary is notified no later than one half hour prior to the start of the first class in the trial, the entry fee will be refunded, minus a processing fee of \$5 per dog per day. The Trial Committee will convene as a result of any damage to hotel, motel, trial premises or on complaints of abusiveness to judges, stewards, workers or dogs. All exhibitors are kindly requested to assist in maintaining the cleanliness of the facility and the grounds or hotels. 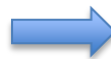
