Unsigned Entry Forms cannot be accepted nor entries which specify any conditions as to its acceptance. Entry Forms **MUST** be filled out completely. Incomplete entries do not constitute a valid entry.

Owners are responsible for errors in making out entry forms, whoever may make such errors, & no entry will be refunded in event of such errors or cancellation of entries after published closing date. PLEASE PRINT OR TYPE CLEARLY. **NO STAPLES OR TAPE PLEASE.**

**Illegible entries** will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry and the Trial Secretary will add a \$25 collection fee to the amount of each returned check.

### RIBBONS, AWARDS, AND PRIZES

Flat ribbons will be awarded in each jump height division in each class as follows:

*First Place..... Blue*  
*Second Place..... Red*  
*Third Place..... Yellow*  
*Fourth Place..... White*  
*Qualifying Score..... Dark Green flat ribbon*

A new title rosette will be awarded to all dog and handler teams finishing a title. A bar and large rosette will be awarded to all dog and handler teams that attain their MACH, PACH or PAX. Please notify the trial chairperson if you have an opportunity to earn your MACH or PACH at this trial

### NOTICE TO EXHIBITORS

Dog Obedience Club Of Lee County, the trial secretary, their agents, etc., assume no responsibility for any loss, damage, or injury sustained by exhibitors or their dogs or property, and further assume no responsibility for injury to children not under the control of their parents or guardians.

IF IT IS NECESSARY TO RESCUE A DOG from a parked car on the show grounds, the Club will not be responsible or liable for any damage to the car involved.

Owners or handlers entering dogs in a trial do so at their own risk and agree to assume responsibility for any damage caused by them, or by their dogs. They also agree to abide by the Rules of the American Kennel Club and the current edition of the AKC Agility Regulations.

The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all the obstacles safely.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such cases, no refund of any fees paid will be made.

### MIXED HEIGHTS & CLASSES

#### **Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend – Multiple Jump Heights Within the Same Trial Day**

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

**A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.**

## FEO & FIX N GO

### Entering For Exhibition Only (FEO)

FEO allows exhibitors to work with their dogs in a trial environment. FEO is only offered in the Time 2 Beat and FAST classes. Participation in FEO is non-qualifying.

- FEO runs are treated as trial entries. The exhibitor must enter the class(es) (T2B and/or FAST) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master). If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out. FEO may be declared earlier (ex. when checking in at the gate board).
- Toys are allowed in the ring. Toys must be non-audible and may not leave the handlers hand. Toys that roll freely may not be used.
- Food/treats are not allowed in the ring
- FEO should be utilized for the benefit of the dog and not as a punitive correction. Harsh verbal and /or physical corrections shall not be tolerated. Any determination of harshness by the judge shall be immediately whistled and the handler will be dismissed from the ring.
- A judge must monitor the entire run. Judges can stop a run at any time

### Fix and Go On

FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score. Fix and Go On is not pre-entered; rather, it occurs during the run.

## COURSE FAMILIARIZATION AND WARM-UPS

The walk-through is restricted to handlers entered only in that class.

## REFUNDS

**No entry fee** will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. Entry fee will not be refunded in the event that the dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee or if the trial cannot open or be completed by reason of civil disturbances, fire, or any other cause beyond the control of the organizing committee.

**Bitches in season** will not be admitted to the trial. Any exhibitor with an entered bitch in season, on the trial date, will be refunded the entry fee, less \$5.00 per run (each day), upon written certification from a veterinarian. Notification must be in the hands of the Trial Secretary no later than 30 minutes before the start time on the date of the trial.

## MOVE UPS

Written requests for dogs to be moved-up to a higher class, as a result of qualifying for an agility title, will be accepted at the trial secretary's address or via email until **6:00 pm on Monday, May 2 2022** and will be included in the running order.

## AFTER CLOSING WAIT LIST

**A waiting list will be maintained for these trials once they have closed on April 27, 2022 2021.**

**The waiting list will be active until its deadline - Saturday, April 30, 2022 at 6:00 pm.** Any runs that are entered in these trials at closing and pulled before the waiting list deadline will be replaced, if possible, by runs in order on the waiting list, and the exhibitor will be reimbursed for the number of runs replaced. If a run is pulled, but cannot be replaced, the exhibitor will not receive a refund and the dog will be considered absent from the run. Entry fees for runs on the waiting list that do not get into the trial by the waiting list closing date, will be refunded in full.

## INSTRUCTIONS

Handlers whose dogs measure into the 8" through 20" regular jump height divisions may opt to enter in a higher or 24-choice **height division** for all **Regular** titling classes, but not in a division lower than their proper height division. Dogs who measure into the 24" regular jump height division may not enter 24-choice. Dogs entered in the **Preferred** classes **must** compete at the required jump height and **may not** compete in a jump height division **higher or lower** than their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or *back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the **AKC Canine Partners<sup>SM</sup>** program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

**Junior Handlers** should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767.
