Move Ups between trials will be offered. Handler must fill out the AKC Class Transfer Form and place in the marked box as soon as your dog is crated.

DOGS ELIGIBLE TO ENTER

This trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete.

Condition of the Dog. Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the search. Dogs with bandages, sutures, or visible wounds are not eligible. Deaf dogs and blind dogs are allowed to enter. Dogs that are both deaf and blind are able to participate so long as the handler is in control of the dog at all times, the dog can complete the requirements of the class, and the dog does not appear to be under undue stress in the opinion of the judge.

ENTRY FEES

Detective entry* \$50. First entry* Novice-Master \$30; Additional entries* in the same trial \$25.

*an entry is defined as a **single run by a single dog in a single class**. Entry fees include a \$3.50 per run AKC recording fee.

cash. No entries will be accepted by phone, email, fax, or hand delivery. No entry shall be made, and no entry shall be accepted, which specifies any conditions as to its acceptance. Returned checks do not constitute a valid entry and the Trial Secretary will add a \$25.00 collection fee to the amount of each returned check.

WAIT LIST INFORMATION

OTCPBC is offering a wait list to fill openings created by withdrawn entries after the trial's closing date/time. A maximum of **50 entries per day** will be placed on the club's wait list. All entries, including wait-listed entries, must be received by the Trial Secretary prior to the posted **closing date/time**. No entries may be withdrawn with a refund after closing date/time unless a withdrawn entry is replaced by a wait-listed entry. If a withdrawn entry is replaced by a wait-listed entry, a full refund will be issued for the withdrawn entry. Any wait-listed entry that does not move off the wait list into the trial will receive a full refund. Runs reserved for Detective that are still remaining at closing will be available to be filled by wait-listed entries.

STAGING AREA, HANDLER'S BRIEFING, AND WARM-UP INFORMATION

Staging Area will be out of view of search area(s). Staging area will include crating, warm-up and waiting area, the Welcome Pavilion for check-ins and posting of running order and results, as well as the Rest Rooms and the trial secretary office.

The **Handler's Briefing** will take place in view of the search area prior to the start of each class after the hide(s) have been set and after the Demo Dog has run. In the Handler's Briefing the judge will explain if there's an off-leash option, number of hides, maximum height of hides and maximum time for the search. **NO DOGS** are to be present during the Handler's Briefing.

A **warm-up area**: the club shall designate a warm-up area. One labelled container per target odor being used in the trial on that day will be placed in the warm-up area. This will allow handler-dog teams to prepare themselves for the search prior to their run. Each team should limit their warm-up to two minutes or less so that others may be able to use the warm-up area as well. The club may also place blank containers.

SEARCH AREA AND RING CONDITIONS

Search areas may be of any shape and of the size specified in the Regulations for each class. **Search Area Conditions.** Searches may be indoors on matted, carpeted, concrete or tiled surfaces or outdoors on uneven surfaces such as grass, mulch, gravel, sand, earth, concrete, or asphalt and wooded areas.

ADDITIONAL SITE INFORMATION

Trial Site. It is not appropriate to scout the trial location prior to the trial date. Many search locations are real-life environments. Such visits may risk the host losing the opportunity to use the location in the future.

The trial will take place at a Boy Scout camp with gravel as well as uneven grassy surfaces and wooded areas. Trials require covering extensive distances to get to and from the parking area to each of the search areas and require that this be done across natural, uneven surfaces. Handlers should be prepared for the physical demands and must be able to navigate the terrain with their dog accordingly. Use of vehicles is limited to the parking lot.

In order to maintain the integrity of the search areas, exhibitors will remain in the parking area except when using the Rest Rooms, accessing the trial secretary, or staging for a search. While moving to or from a search area, exhibitors will follow designated routes.

Handlers should be prepared to deal with a variety of weather conditions, including heat, wind, and heavy rain. Although the trial site is a developed scout camp, please be aware that alligators and other predators inhabit this part of south Florida. Safety first. Please stay away from bodies of water and do not feed the wildlife.

Possession of Odors and Training. Chapter 5. Section 35 of the Scent Work Regulations state “No person other than those engaged in the administration of a trial shall be in possession of any target odor when on the trial grounds. There shall be no training on the grounds of the AKC Scent Work trial, other than the designated warm-up area”.

Spectator Area. Spectators may be limited by space constraints. No one outside the search area may assist the handler or disclose the location of the hide.

Indoor crating space will not be available. **Participants are required to crate at their vehicles.** Participants should expect to spend most of the day outside or in their vehicles as there are no indoor crating options at these trials. Parking lot is gravel surface with very limited shade. Please be prepared for you and your canine partner to deal with all of these varying environmental challenges. In order to preserve the integrity of the search areas, exhibitors will not be able to walk freely throughout the site. Out of consideration for all exhibitors, exhibitors wishing to run vehicles need to park in a designated area within the parking area.

There will be limited parking for RVs in the competitor parking lot due to the size of the parking lot. Pre-approval is required. Send request to: **otcpbc.trialsec@gmail.com**. No RVs may be parked at the site overnight.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

RIBBONS, AWARDS, AND PRIZES

Placement ribbons will be awarded in each class as follows:

- First Place*.....*Blue*
- Second Place*.....*Red*
- Third Place*.....*Yellow*
- Fourth Place*.....*White*
- Qualifying Score*.....*Dark Green*

A **New Title rosette** will be awarded to dogs finishing a title.

High in Trial

Only teams who participate in the same difficulty level in all elements offered (Container, Interior, Exterior, Buried) and qualify in each are eligible to win **High in Trial**. One High in Trial winner is chosen per difficulty level; there is no separate High In Trial for the Novice A and Novice B sections. The High in Trial is determined by adding the team’s faults across the elements. If there is a tie based on faults, then the team’s times across the elements will be summed and the faster-finishing team will win. The High in Trial award is not recorded by the AKC. **HIT will be offered.**

High Combined Division (HCD)

If a club chooses to offer the High in Trial (HIT) award and is also offering Handler Discrimination classes, they must also confer the High Combined Division (HCD) awards. Only teams who participate in the same difficulty level in all elements plus Handler Discrimination, and qualify in each, are eligible to win High Combined Division. The High Combined Division award is determined by adding a team’s faults across all classes. The team with the fewest faults will be declared the winner of the High Combined Division. The High Combined Division award is not recorded by the AKC. **High Combined is not available for this trial.**

NOTICE TO EXHIBITORS

SAFETY, BEHAVIOR and LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all searches safely. **It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The Obedience Training Club of Palm Beach County (OTCPBC) and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property, and further assumes no responsibility for injury to children. The OTCPBC reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the OTCPBC or any official thereof.

Collars, Leashes and Harnesses. During searches, dogs must wear a properly fitted collar or harness approved by the judge. A wearable camera such as a Go Pro may be mounted to the dog's harness, if desired. Leashes may be of any length and/or retractable. The leash should be made of plain, pliable material.

All dogs must be on leash at all times, and retractable leashes may not be used when on trial grounds (except during judged searches). Dogs must enter and exit the search area with the leash attached to the collar or harness, including when waiting in the search area before and after the search. For Novice-Master classes, an off-leash option may be offered at the discretion of the judge if the area is completely enclosed. For the Detective class handlers have the option to run off-leash.

REFUNDS:

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. Dogs pulled after closing because of injury or other medical condition are not eligible for a refund.

Bitches in season will be refunded the full entry fee. Notification in writing must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of the trial.

RINGSIDE:

Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at the search area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

EXHIBITOR CHECK-IN: At check-in you will receive your armband number. Once the time and location for check-in is determined all exhibitors will be notified by email. You will also need to sign the Waiver required by the trial site, Boy Scouts of America (BSA).

Exhibitors MUST check-in and sign the BSA site waiver EACH day they are entered.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

ATTENTION EXHIBITORS

By signing and submitting this entry, you agree to the following:

OTCPBC and Boy Scouts of America (BSA) assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, visitors or to any of their dogs or property, and further assume no responsibility for injury to children. The welfare of children is the responsibility of the parents or guardian. They must exercise control and restraint over their children at all times. Any and all damages caused by the exhibitor, exhibitor's dogs or children will be the sole responsibility of the exhibitor.

IF IT IS NECESSARY TO RESCUE A DOG from a parked car on the show grounds, the Club will not be responsible or liable for any damage to the car involved.

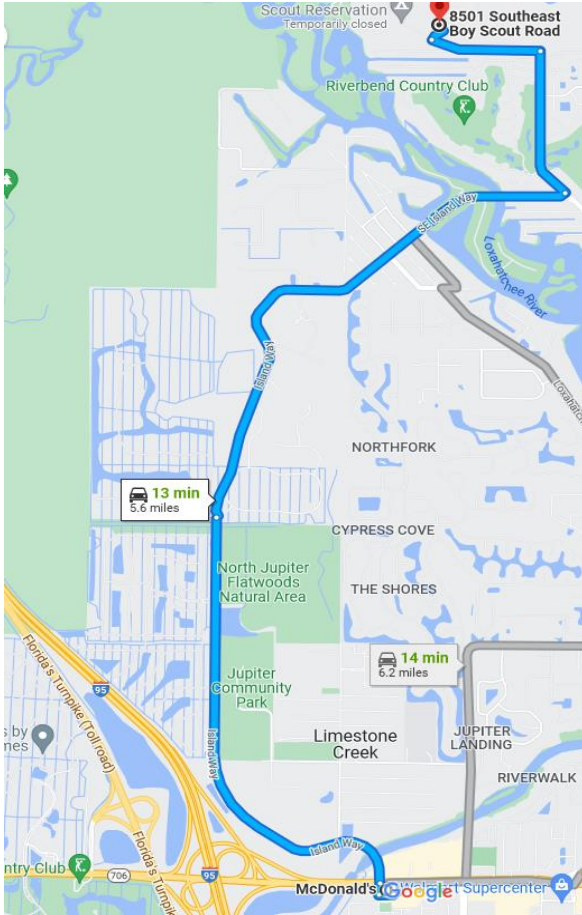

Via I-95 (N or S)

Take Exit 87A, Jupiter, W Indiantown Rd. Merge onto Indiantown Rd. Head east to the first traffic intersection and use left lanes to turn left onto Island Way.

Via FL Turnpike (N or S)

Take Exit 116, Jupiter. Use center left lane to head east on W Indiantown Rd. Continue to the first traffic intersection and use left lanes to turn onto Island Way.

Once you have turned left onto Island Way, you will be heading north. You will run into a traffic circle. Continue straight to stay on Island Way. Island Way ends at SE Country Club Dr. Turn left onto SE Country Club Dr. SE Country Club Dr. turns left and becomes SE Boy Scout Road. Continue to 8501 SE Boy Scout Road.

EXAMPLES TO HELP YOU CALCULATE YOUR ENTRY FEES

- A) Four trials (2 Sat. & 2 Sun.) one class entered (excluding Detective): $4 \times \$30 = \120
- B) Two Trials (1 Sat. and 1 Sun.) showing Detective: $2 \times \$50 = \100
- C) *Sat. Trial 1*: Detective (\$50), Buried Excellent \$25 & Interior Excellent \$25 = \$100 for *Sat. Trial 1*. *Sat. Trial 2*: Buried Excellent \$30 & Interior Excellent \$25 = \$55 for Trial 2. **TOTAL FOR SAT. IN THIS EXAMPLE: \$155.** Repeat for Sunday.
- D) *Sat. Trial 1*: Interior Novice (A or B) \$30 & Exterior Adv. \$25: Total for Sat. Trial 1 = \$55. *Sat. Trial 2*: Buried Advanced \$30 & Exterior Excellent \$25: Total for Sat. Trial 2 = \$55. **TOTAL FOR SAT. IN THIS EXAMPLE: \$110.** Repeat for Sunday.

For each dog you are allowed one entry per level for the same element and a maximum of two entries per element per trial. You may not enter two dogs in the same element/level class. Novice A/B classes are considered separate only for placement. Please email the Trial Secretary for assistance in calculating entry fees.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim of loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person. I (we) agree that the determination of whether the injury is serious shall be made by the event veterinarian and is binding on me (us). I (WE) AGREE THAT ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THE ENTRY, EXHIBITION OR ATTENDANCE AT THE EVENT BETWEEN THE AKC AND THE EVENT-GIVING CLUB (UNLESS OTHERWISE STATED IN THIS PREMIUM LIST) AND MYSELF (OURSELVES) OR AS TO THE CONSTRUCTION, INTERPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION PURSUANT TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION. HOWEVER, PRIOR TO ARBITRATION ALL APPLICABLE AKC BYLAWS, RULES, REGULATIONS, AND PROCEDURES MUST FIRST BE FOLLOWED AS SET FORTH IN THE AKC CHARTER AND BYLAWS, RULES, REGULATIONS, PUBLISHED POLICIES AND GUIDELINES.

INSTRUCTIONS

Novice A Classes are open to dogs who have not completed any title for that particular element, who have not completed a comparable title with another organization, and whose handlers are neither Scent Work judges, nor have ever worked as professional detection dog handlers. Novice B Classes are open to all dogs. You may not enter a level until you have titled in the previous level for the element. You are allowed one entry per level and a maximum of 2 entries per element, per trial, per dog. (An element is container, exterior, interior, and buried). HIT teams must qualify in **all the elements** offered for the level.
