Minutes approved from November 2022 meeting.

Reports:

President – Betty Gansky. Thanked the members for being more conscious of the small things they can do to keep the clubhouse looking nice, such as stones on the floor or excess hair floating around. Everything has been so much neater since she mentioned this at the last meeting.

She also showed a chart as to the costs involved with running the building.

Obedience Coordinator – Nancy Honchar – NO REPORT.

Rally Coordinator- Steve Campbell – Trials 19 & 20 in April 2023. Noreen Noonan and a new judge, Jenette Rogers will be judging. The Rally trial in November made a nice profit. Rally classes on-going **Agility Coordinator** –Barbara Bounds – No Report

Scent Coordinator – Judy McPartland - Thanks to all that helped with the scent trial over the November 2022 Thanksgiving weekend. It was a very large event. There were 248 qualifiers out of 462 runs. There is also a January 28 & 29, 2023 scent trial coming up at the clubhouse.

Scent Trial Chair – Donna Kornmeyer. Volunteers are needed Sunday. Both the building and practice field will be used during the trial.

Tracking Coordinator – Diana Johnson Ford – There was a tracking test the weekend of January 7 & 8. There was a pass in VST, Trisha Boychuk and her poodle. Angel Andrews and her Carin Terrier Jolene earned their TDU title with a pass. Paperwork is being done at this time to add a TDU test in April 2023. This is a new date for the program.

Webmaster – Judy McPartland. Webpages look a bit different because a new tool is being used. Registration for classes opened in December. There are 199 registrations for January classes to date.

The new tool allows more pictures to be put on the website. Judy is looking for action pictures. High quality. Make sure you own the rights to the pictures. You can contact Judy McPartland @ mcpartlandjudy@gmail.com

Election of Officers: The Secretary cast the vote to elect the 2023 Board of Directors. Betty Gansky, President; Steve Campbell, Vice President; Fran Smith, Treasurer; Celeste Platte, Secretary; Scott T Adams, Sr, Tracey Guziejka, and Nancy Honchar, Members at Large.

New Business:

Maintenance - Tracey Guziejka: Since October 2022 the following maintenance issues have been addressed.

- The building lights in the training room have been switched from regular bulbs to LED costing us less in electricity and lasting longer.
- New fixtures installed on the top of the field shed and the front of the building facing the street.

- New LED lights installed on the brick sign out front. Also, a new fixture on the west side of the building facing the practice field. Still working on installation.
- Sprinklers in the practice field are scheduled to go on Mondays and Thursday from 4 AM 6 AM.
- The shrubs in front of the building have been removed. There was a massive buildup of mildew on the building. The front of the building will be power washed and painted. Shrubs will be replaced and set out from the building once the fungus in the grass is completely gone.
- A new rain-bird box was installed replacing the worn out old one. This times the operation of the sprinklers.
- Shrubbery trim on the side of the building covering the sidewalk.
- In the back of the building where the air conditioners are, the electric boxes were rusted out and have been repaired. The fire sprinkler waterspouts were painted red according to regulations.
- A gutter high on the building has been repaired.
- The insulation hanging down at the back of the building by the roll up door has been repaired.
- The leak behind the steward table has been a mystery for almost a year. It appears there was a pipe dislodged inside the utility closet that was causing the leak. That has been reconnected.

Practice Field Signup – Diana Johnson-Ford. Since the last meeting, there has been a signup process instituted using Google Docs that those who have paid for field usage can look at to schedule field time. As of right now, the system is working nicely.

- The Storage closet next to the handicapped bathroom has been redone with new shelving and better arrangement. The ceiling will be painted, and trim put down on the floor after the season is over. - The upstairs loft is being cleaned of excess items and more shelving installed to better organize what is up there.
- The location of June General Membership meeting: The Board discussed whether the club should have at least one meeting in person. It was decided to stay with the Zoom meetings and hopefully be able to plan a holiday party at the end of this year.

Old Business

- Building Maintenance Status Report Supplied by Tracey Guziejka,
 - The bushes have been installed in front of building...set out from building so there is not a buildup of mold on the building again.

- The sprinklers in front of building have been fixed and some new ones installed.
- A metal landscape boarder was placed around the front of the sign and landscape trim will also be placed along the new bushes.
- The 3 tall palm trees in the front were thinned out...allowing more sun to come through minimizing the fungus we have been battling with on the front lawn.
- Very tall tree-like weeds were removed from behind the large shed and that area is being cleaned up.
- The water leak we have been investigating is now being addressed again...what we thought caused it...was not the cause.
- We are in the process of waterproofing the back of the building facing Mullinax Ford's car lot.
- We noticed their property sits much higher than our property. Water run-off may be causing our water intrusion problem.
- Meet with the Lake Park code enforcers and they agreed.
- We will meet with General manager Jennifer Mesa of Mullinex Ford, to address this issue.
- Hopefully, they will agree to cutting a swale on their side of the fence to divert water away from our building. If they do not agree to this, the building department will get involved.

Obedience Coordinator – Nancy Honchar. Two obedience trials are scheduled in the near future. Miami Obedience Club on May 28 & 29 at the OTCPBC building) then two weeks later OTCPBC on June 10 & 11. There will be an Obedience Show and Go May 21 (online entries open April 21) and June 4 (online

entries open May 1). There will be a Rally Show and Go on April 23 which you can register for now online at the club website.

Rally Coordinator- Steve Campbell – For the Rally Show and Go on April 23rd, Sandy Gates will be judging Master, Excellent and Advanced. Mary Macchia will just the balance of the classes. The judges for the Rally trial (two trials per day) are Jenette Rogers and Brenda Critelli

JANUARY 2023 OTCPBC AKC SCENT WORK TRIAL

Comfortable trialing weather and friendly volunteers greeted competitors at OTCPBC'S eleventh Scent Work trial the weekend of January 28-29, 2023.

A Scent Work trial depends on folks who are not competing at the trial to fulfill the stewarding roles where the placement of the hide is known to the volunteers. This brings together volunteers with many interests: volunteers experienced in obedience, rally, tracking, conformation, as well as folks just starting out in scent work or more advanced Scent Work competitors helping during classes in which they have already titled.

This was OTCPBC's third AKC Scent Work trial with multiple "rings" running simultaneously. Handler Discrimination Novice and Excellent classes ran in the Practice Field. Handler Discrimination Advanced, Interiors Novice, Advanced and Excellent ran in the building.

Outdoors, volunteers helped competitors know when their turn was coming up for each of the two rings and were encouraging as teams got ready to do their searches. Timers, HD Stewards, prop setters, gate stewards provided a calm atmosphere allowing competitors to focus on being a team doing a search.



A big shout out to all who helped with setup on Friday prior to our trial and to all who stayed to help clean up and get our building back in order. Especially notable was the creativity of those who helped set up both inside the building and outside in the practice field and to those who got everything back in order after the trial. HD boxes were put together. Obedience equipment and ring gates were moved out to the shed and then back into the building. Rings were measured and ring boundaries marked. Volunteers arrived with tools, (drills, screw drivers, hammers, Allen wrenches) and then used much creativity in putting together bookcases, side tables and waffle blocks to be used in interior searches. And at the end, they used the same creativity to take items apart and pack them back into storage boxes.



Linda Anne Wood, Dean of Broward College's Institute of Public Safety, passed away peacefully on Thursday, January 5th, surrounded by her family and close friends after her brave and determined battle against pancreatic cancer.

For the past 27 years, Linda dedicated her life to serving the community as an administrator, educator, author, mentor, and advocate for both law enforcement and those experiencing homelessness. Born in Plainfield NJ, Linda earned a bachelor's degree in criminal justice from the College of New Jersey, a master's degree in public administration from Temple University and a certificate in non-profit management from Florida Atlantic University.

Linda moved to Broward County in 1995 to join the Broward Sheriff's Office as Assistant Director for Community Corrections. In 1998 Linda joined the Institute of Public Safety (IPS) at Broward College, serving as the Associate Dean/Director of Professional and Executive Development/Career Training Administrator. Linda became the Dean of the Institute of Public Safety in 2007.

Linda continually displayed her passion and determination to enhance the development of all law enforcement professionals in Broward County, ensuring that each law enforcement agency and correctional institution received the best trained law enforcement personnel. Along with the Police Academy, as Dean, she also oversaw the Criminal Justice Program and Professional & Executive Development which oversees the Regional Testing Center which is responsible for the testing and screening of police applicants. Under her leadership, the police and correctional academies were able to successfully graduate more than 300 law enforcement and correctional cadets a year. Linda was not just the Dean; she was also a friend and mentor to many of the graduates providing strong words of encouragement and support throughout their careers.

Linda faced cancer like she did everything in her life - with determination and strength beyond comprehension. When she got knocked down, she got back up. Despite Linda's metastatic cancer diagnosis, she continued to be of service to others, as a mentor, a colleague, a friend, living each day at a time with integrity and humility. Linda lived strong and her fierce determination is an inspiration to everyone who knew her.

Linda was an exceptional high school varsity athlete (softball, basketball and field hockey) who enjoyed all types of physical activities throughout her life. One of her greatest joys was her time spent with her devoted dog "Bo" as they competed in obedience and agility trials.

Linda is survived by her spouse, Kathryn Kominars; brother and sister-in law, Kenneth and BJ Wood; nieces, Amanda, Stephanie, Sarah; nephews, Henriques, Jared, Kevin, Derek; and great-nieces and nephew Adalynn, Amelia, Xavier, Elizabeth.


