Call to order.

MOTION to approve the minutes from the June 5, 2023, General Membership meeting as published in Lead Lines. 1 st Nancy Honchar 2nd Betty Gansky. Motion approved.

Reports:

President – Betty Gansky: No report

Vice President – Steve Campbell ABSENT

Secretary – Celeste Platte: Reminder about the Obedience Trials for OTCPBC on November 11 & 12 and Jupiter Tequesta Dog Club obedience trial on October 21 & 22. Premiums for both trials are on the pass-thru at the club as well as online at OTCPBC.org and jupitertequestadogclub.org.

Treasurer – Fran Smith: Fran gave a report on the club's finances. Despite the club having a lot of maintenance costs in the last few months including new air conditioners, we are still in good financial shape/

Obedience Coordinator – Nancy Honchar: The Rally Premium will be available September 27 th . You will be able to enter online this year. There will be an Obedience Show and Go on October 29 and a Rally Show and Go on November 5. These events are by pre-registration online. Go to OTCPBC.org, Trials and Seminars, and choose the discipline you are interested in.

Nancy will be sending out a questionnaire to members about what classes they would like to see offered.

Rally Coordinator – Steve Campbell, Absent. by Betty Gansky A nice profit was made for the July Rally trial.

Agility Coordinator – Barbara Bounds: Five classes were offered this last session and they were all full. Five classes will be offered later this year and 2024.

Scent Coordinator – Judy McPartland: There is a Nosework Trial scheduled for November 25 & Description 25 will be able to enter online once the entries open. There is a Sniff and Go scheduled for Friday, September 22, pending the scheduled road work. This event may be rescheduled because of this work.

Tracking Coordinator – Diana Johnson Ford:Fran Smith reported: A TDX tracking test is scheduled in November and another TDX is scheduled for December 5. January there are scheduled tests for VST & TDU.

New Business

DOCOF Report – Lodge Weber – Report by Ron Seeley. 12 Obedience teams and 11 rally teams participated this year. Next year Rally legs can be earned while showing at DOCOF. This has applied to the Obedience venue the last 2 years. Preferred entries will be accepted in '2024. Preferred entries can count as part of the three-member Obedience team.

Gateway Road repaving and closure - Gansky

The club just received notice of the roadway work on Gateway Road on Friday September 15, which is scheduled to begin on Monday, September 18. The closure of classes will be evaluated each

day by the Board of Directors depending on the progress of the resurfacing. This also applies to day training by the access card holders.
