#### Maintenance:

• Shed for Scent Work - The City of Lake Park now requires all permit requests to be submitted online. The City rejected the permit due to insurance concerns by the city. Betty will call another shed company and see if they can pull a permit from

the City. Another option in place of the shed would be a shipping container. This container can be painted according to the owner's preference. They can have open doors or roll up doors. These containers can be designed to be anything the owner wants. These containers are more secure than sheds.

- Roof Maintenance- The roof will be inspected this April, as it is every year. This will not disrupt the classes.
- Nozzle Nolan will be inspecting the sheds for termites. The membership will be notified if treatment is planned.

Vice President – Lodge Weber. Great Show & amp; Go on Sunday, June 2

**Treasurer –** Fran Smith. Fran gave a report on the finances of the club's finances, **Secretary** – Celeste Platte. The June Obedience Trial has the largest entries since pre-pandemic days

Scent Coordinator – Judy McPartland. A new storage unit on Water Tower Road was rented for the scent equipment. An Odor Recognition Test is scheduled for October 13, 2024. A NACSW trial will be at St Lucie County Fairgrounds, Ft. Pierce, the last weekend in April. The application has been submitted. No levels are known at this time.

Webmaster – Judy McPartland. New people are learning to input information.

#### **New Business:**

- Chairs and crates in the crate room Gansky. Everyone should have received an email to remove all personal chairs and crates by the end of June. The instructors can leave their equipment if they are continuously teaching.
- Red Ants. A treatment was done in the front yard and the practice field
- Insurance Cover for building Guziejka. Hurricane preparation plans: The awning is removed. Tommy (out lawn maintenance) places sandbags around the doors. The bags are kept in the shed.
- The roof was inspected. Just a few screws were needed. After hurricane season, the crew will return to discuss more about the roof.
- Diana All the large agility equipment is put in the shed. There is nothing that would be in the field for most of the hurricane season. The Agility Coordinator should be called if equipment needs to be moved. There are specific ways each piece needs to be disassembled.
- Insurance on the building: The club has General Liability/personal injury, and theft/crime coverage. The club does not carry wind insurance as it is cost prohibitive.
- Club Air Conditioners Two of the four air conditioners have been replaced over the last two years. They receive regular maintenance.
- Agility Equipment needs to be refurbished. Johnson-Ford. A request will be made for some new equipment to accommodate the puppies we have registering. Also, some of the current equipment needs to be refurbished. The Agility Coordinator will be overseeing that work.
- Show and Goes Jim Pirko has agreed to do the scheduling sheets and send them
  out to those entered. Jim will coordinate the Show and Go for the end of June 30.
  A show and go at the end of August, August 25, before DOCOF. An email will be
  sent out to the membership asking for volunteers for the upcoming event.
- Plans are being made to have on-line volunteer signs for the different events the club holds. When that is in place, the Secretary will send out the information to the membership.
- Drill Class Drop-in class will start 6/21 11:30 AM. Other dates right now are 6/28 and 7/12. More dates are planned to be added after these classes. The charge is \$10 cash, exact change paid at the time you arrive. No pre-registration is needed. Just show up.
- Termites Tracey The Club has canceled its contract with Nozzle Nolen due to inconsistent scheduling. A contract has been signed with Southeast Florida Pest Control (Southeast). Southeast inspected the building and found remnants of termites on the south side of the building. The problem has been caught early. Local treatment is all that is needed. When scheduled, the membership will be notified of the building closure during treatment.
- Club Christmas Dinner Cindy Ponga has agreed to coordinate the club's Christmas dinner at Buongiorno Restaurant on Northlake Blvd. More information as the time grows closer.


# In May, Aries and I attempted the virtual NACSW skills challenges at a level 3.

From there forward there were cubicles from there to the entry of where we now have our crate room. The small kitchen that the previous business had in place was where we have our crate room.

Ray stepped-up-to the plate & began working with Shawn Smith (no longer a member) & my husband Jeff. The pictures I've included were taken by Liese, Ray's wife in June & July of '12.





Unfortunately there are no pictures taken with Shawn in them. Shawn was working as a fireman & came whenever he could. He too did a tremendous amount of time volunteering on his days off.

Ray moved the kitchen from the crate room & placed it where it is now located. It's not the same kitchen. OTC renovated the kitchen to what it is today years later.



The team also had to ready the floors inside as well as work on the parking lot.

I just had to share what a "Godsend" Ray was to OTC. None of the three received any monetary compensation. We paid cash for the building thanks to Buzz Taylor but there was not a lot left over to do what needed to be done to make the building usable.

The trio volunteered endless hours/months even through the heat of the summer without A/C to achieve this goal.
