New Business:

- Approval to proceed with the Obedience Seminar by Anna Marie Scripko as planned by Ron Seely.
 - The Board approved the information submitted by Ron Seeley to proceed with an obedience seminar by Anna Marie Scripko. The seminar will be held on February 22 & 23, 2025. The cost is \$225 for a two-day working spot. Limited to 20 participants. Audit spots will be available for \$75 per day, limited to 10 spots per day. Lunch will be provided.
 - Registration will be available online at the OTCPCB.org website. An announcement will be sent to the membership by the secretary when registration is open.
- Two-month advance payment to our lawn maintenance crew. The Board has approved such payments in the past to assist our maintenance crew.
 - MOTION to approve the prepayment of two months to the club's lawn maintenance crew.
 - 1st Guziejka 2nd Smith. Approved.
- Club Email Policy – Smith
 - Emails to the club membership shall be limited to news of the club's events and pertinent information.
- Recommendation of Private Training.
 - OTCPCB does not offer private training. The club's mission statement is to offer training classes to the general public and members. The Board of Directors, for legal reasons, feels that recommendations for private training should not be made to the public.
- Survey to be sent to students at the completion of a class – Adams
 - Scott recommended sending a survey to students at the completion of the class.
 - The following is an example of questions to be send:
 - How was your experience
 - How would you rate the class
 - Did you and your dog learn something from the class
 - Would you take another class from OTC based on your experience

- What other types of classes would the student like to see?
 - A lot of the information requested is available through other means. If the survey concept moves forward, what is the scale to be used? A rating scale? A write in. Who receives this survey? The coordinators? What is going to be done with the information. It was decided that if surveys are sent to students, they should go to the appropriate coordinator.
 - Is this going to be required for all classes? Should the sending out of surveys be left up to the teachers?
 - This may be a good project for a member to volunteer to send the surveys to the class participants.
 - There was no decision by the Board on this recommendation.
- Free Access Cards for Instructors – Gansky POSTPONED
- Class fees. Prorated when class meets for other than six weeks. McPartland POSTPONED
- The number of Volunteer hours needed to be eligible for Member Benefits is 20 hours. Per P&P Board reviews annually. – McPartland POSTPONED
- Membership Meeting dates and zoom or in-person. Makes a difference in how Monday evening is available for classes, especially for puppy classes where “missed weeks”; don’t work very well. – McPartland POSTPONED
- We need a Privacy Policy statement that can be posted on our website. McPartland POSTPONED

Call to order.

Motion to approve the minutes of the June 3, 2024 General Membership meeting. 1st Scott T.Adams, Sr. 2nd Fran Smith. Motion passed.

Reports:

President – Betty Gansky. There have been a lot of events, and all have gone well. Betty gave a financial report of the obedience, rally, and agility trial.

Vice President – Lodge Weber. Lodge had the honor of substituting some Rally classes for Scott. He really enjoyed it. Lodge thanked everyone for their support and the volunteers the club has.

Treasurer – Fran Smith. Fran gave a report on the club’s finances. Fran would like to have a member volunteer to be an understudy to learn about the Treasurer’s job and duties. There are many things the Treasurer does, just not write checks.

Secretary – Celeste Platte. No report.

Obedience Coordinator – June Feigenblatt. Some new classes have been introduced. Fit Classes 1, 2, and 3, Jumping 101, and a temperament test is scheduled, probably in December.

Rally Coordinator – Scott T Adams, Sr. The rally classes are full. A Show & Go needs to be moved. The Rally show & go's might be moved further out from the trials so people will have an opportunity to fix any problems they may have. Volunteers are still needed for the November Rally trial on November 16 & 17. Contact Scott at scott362@bellsouth.net if you can volunteer some time.

Agility Coordinator – Leslie Granville-Smith. Classes are going well. Leslie is looking into offering Saturday classes in November.

Scent Coordinator – Judy McPartland. October 13 having an Odor Recognition Test. Volunteers are needed on Saturday October 12 at 2:00 pm to help set up. Two more stewards are also needed on Sunday. Contact Judy at mcpartlandjudy@gmail.com. AKC Scent Work trial November 23 and 24th . A call for volunteers will be made shortly.

Tracking Coordinator – Diana Johnson Ford – TDX in November and December 2024. TDU is February 9, 2025. VST February 16, 2025. New tracking classes for beginning trackers will start up in October. Classes are listed up on the website.

Webmaster – Judy McPartland. There are a lot of things available to register. Member renewals are open as well as the Obedience Trial on November 9 and 10. Obedience Show and Go on October 6 is open. A CGC and CGCA test will open on September 13th . The Rally trial will open on September 19. Rally Show and Go for November 3 will open on September 29. The Scent Work trial will open on October 2. The Obedience Show and Go for October 27 will open on October 10. A tricks test will open on November 11.

All the trial dates for 2025 are on the calendar. There may be a tracking test that may need to be resolved.

On November 26 all class registrations will be closed down so behind the scenes work can be done. December 9 is the target date to have the first quarter of 2025 classes listed.

AKC FETCH

What is AKC Fetch?

AKC Fetch is a titling program part of the AKC Family Dog Program. It is a pass-fail noncompetitive test with four levels, Novice, Intermediate, Advanced and Retriever, that assess the retrieving ability of a dog.

Although some dogs are natural retrievers this is a test designed for all breeds. As you move up higher in level more abilities such as memory, response to signals and covering larger distances are tested to increase the challenge.

Tests may be held inside and outside space permitting. The OTC practice field is large enough to host Novice and possibly Intermediate levels. Two passing tests under two different judges are needed to earn each level title and there are a number of OTC members that are already approved AKC Fetch Judges.

Jane Craig and Cindy Porter traveled to Bratty Paws on August 3rd to run in an indoor Fetch test and together they came home with three Novice Fetch titles. Congratulations Astro the Weimaraner, Gunner Beagle and Reyne.
