Move-ups must be requested using AKC Fetch Move-up form which must be presented to the AKC Fetch Test Secretary at least 30 minutes prior to the start of each trial. Exhibitors are responsible for the accuracy of the information on the form. Move-ups may be approved provided the class and judge are available, and the class has not reached its limit.

This trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete.

Condition of the Dog. Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the Fetch test. Dogs with bandages, sutures, or visible wounds are not eligible. Deaf dogs are allowed to enter so long as the handler is in control of the dog at all times, the dog can complete the requirements of the test, and the dog does not appear to be under undue stress in the opinion of the judge.

To receive a title ribbon, two qualifying tests must be completed under two different judges. The qualifying ribbon as well as the Title ribbon will be offered by the Obedience Training Club of Palm Beach County and its' friends and members. A qualifying score is required for all ribbons and prizes.

NOTICE TO EXHIBITORS

SAFETY, BEHAVIOR and LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all test requirements safely. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The American Kennel Club and the Obedience Training Club of Palm Beach County and their agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The American Kennel Club and the Obedience Training Club of Palm Beach County reserve the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the American Kennel Club or the Obedience Training Club of Palm Beach County reary official thereof.

Collars, Leashes, and Harnesses. Dogs must wear a collar. Dogs may wear slip collars, buckle collars, and Martingales in the AKC Fetch test. They must come into the testing area with a leash attached to the collar. They may not wear prong collars, e-collars, head collars, muzzles, or body harnesses. Leashes should be 4 ft. to 6 ft. long and should be made of fabric, leather, or biothane. No Flexi-leashes.

Dogs that leave the testing area during the test are disqualified, even if they return to the test area and resume working. Handlers are encouraged to read the AKC FETCH Judge and Participant Guide for complete guidelines on the test.

REFUNDS

If the club cancels the Fetch test, preregistered entrants will be given a refund for their entry fees.

Entry fees shall not be refunded for absent or disqualified dogs; dogs excused by the judge or a veterinarian; or dogs barred from the competition by the Trial Committee. Any dogs aggressive to persons or dogs shall be removed. If, because of riots, civil disturbance, or other acts beyond control of the hosts, it is impossible to open or complete the show, no refund of entry will be made. Dogs pulled after closing because of injury or other medical conditions are not eligible for a refund.

Bitches in season in season will NOT be admitted to the trial. Any exhibitor with an entered bitch in season, on the trial date, will be refunded the "entry fee", less \$5.00 per test, upon written certification from a veterinarian. Notification must be in the hands of the Trial Secretary no later than 30 minutes before the start time on the day of the trial.

RINGSIDE

Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at the testing area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.
