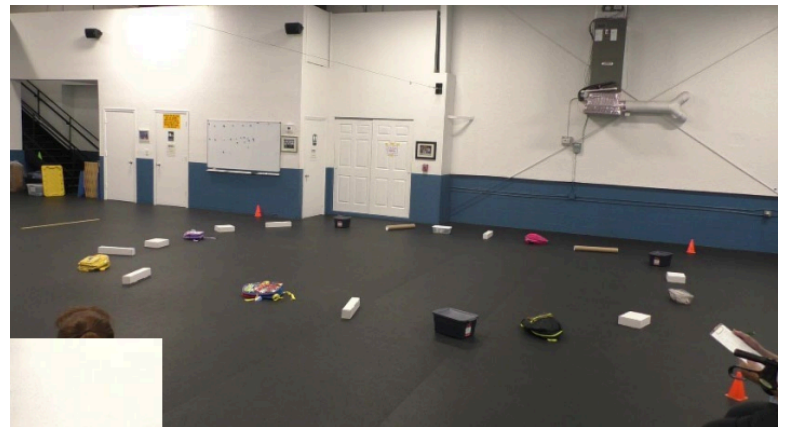
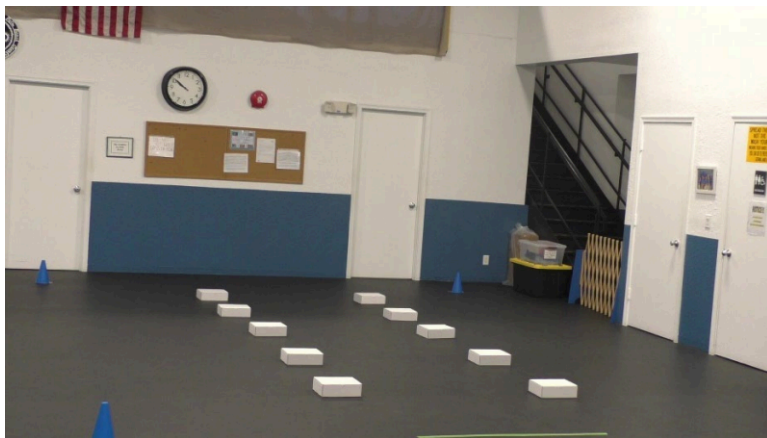


Novice Handler Discrimination & Novice Buried Search Areas

April 2025 NACSW Nosework Trials

Thanks to the generous work of volunteers, the Obedience Training Club of Palm Beach County hosted its third NACSW sanctioned trial event during the weekend of April 26-27, 2025. The trial was held at the St. Lucie County Fairgrounds in Fort Pierce, the same site as its first NACSW trial in 2017.

This weekend we held four trials, two each day. Two of the trials were Element Specialty Trials designed to test the team's ability to search specific elements. The level 1 Exterior (L1E) trial included four searches of Exterior areas, the Level 1 Containers (L1C) included four container searches with containers set in different areas and configurations. The NW1 and NW2 searches tested the team's ability to search all four elements, Exteriors, Interiors, Vehicles, and Containers in a single trial. To title in any of the trials teams needed to find all the hides in every search with no false calls. Hidden within four containers in the NW2 container search were distractors, a toy, some bread, orange pieces and a hard-boiled egg. NW2 had five searches (two separate Interior searches).

NACSW sanctioned trials require specific trial officials at a trial. There must be a Certifying Official who finalizes the areas to be used in each search, sets the hides, supervises the judges and ensures that the trial follows NACSW trial standards. In addition, trials need to have two NACSW approved judges and a trained Score Room Lead. We were happy to welcome Natalie McManus from the St Louis MO area as our Certifying Official, Sinead Imbaro (Police and Military K9 Instructor at K9 Protected) from Miami, Michael Hadsell (of Peace River K9 Search and Rescue <https://www.prsar.org/>) from Englewood, FL, as our two judges and Steve Stirrat from Gainesville as our Score Room Lead.

Competitors may not volunteer in a trial in which they are competing. The four trials over the two days, had a total of 17 searches, each requiring timers, stewards, videographers (for quality control videos required by and sent to NACSW), staging and traffic guides, dogs in white with handlers, score room assistants (data entry and verification of scores), folks lending vehicles for searches, and then set-up, clean-up and transport of materials.

Lauren Walsh deserves huge thanks for recruiting, organizing and training volunteers. And then, yeoman service in working with the Certifying Official, Natalie, on the design of the flow to and from each of the search areas.

While competitors were able to crate in an air-conditioned exhibit hall, Officials and volunteers spent most of their time outdoors. For officials and volunteers the day started at 7:00 am, ending at 6 pm on Saturday and after 3 pm on Sunday.

Cynthia Porter performed pre-trial battery charging and checks on the very essential walkie talkies used during the trial to manage the flow from the exhibit hall to each of the search areas. Lauren picked the Certifying Official, Natalie McManus up at the airport. Jane Craig hosted Natalie overnight, Sunday, and brought her to the airport for her flight on Monday morning.

We welcomed competitors from all over Florida, with the farthest coming from Tallahassee. And it was special to welcome back folks who had competed at our trial at this site in 2017.

On Saturday in the Level 1 Exterior Trial (L1E) 20 teams ran and 13 titled; NW2, 26 teams ran, 7 titled. On Sunday in NW1, 25 teams ran, 15 titled; L1 Containers (L1C) , 23 teams ran, 10 Titled. That is a total of 45 perfect teams for the weekend!

For NACSW the fundamental nature of the sport is to expose the team to real-life search scenarios with varying terrains and environments. The St. Lucie County Fairgrounds provided some very nice real life areas to use for searches. Staff were helpful and friendly. We utilized areas ranging from the restrooms and horse arena in Adams to various barns along the mall.

May 2025 Heart & Paw Celebration

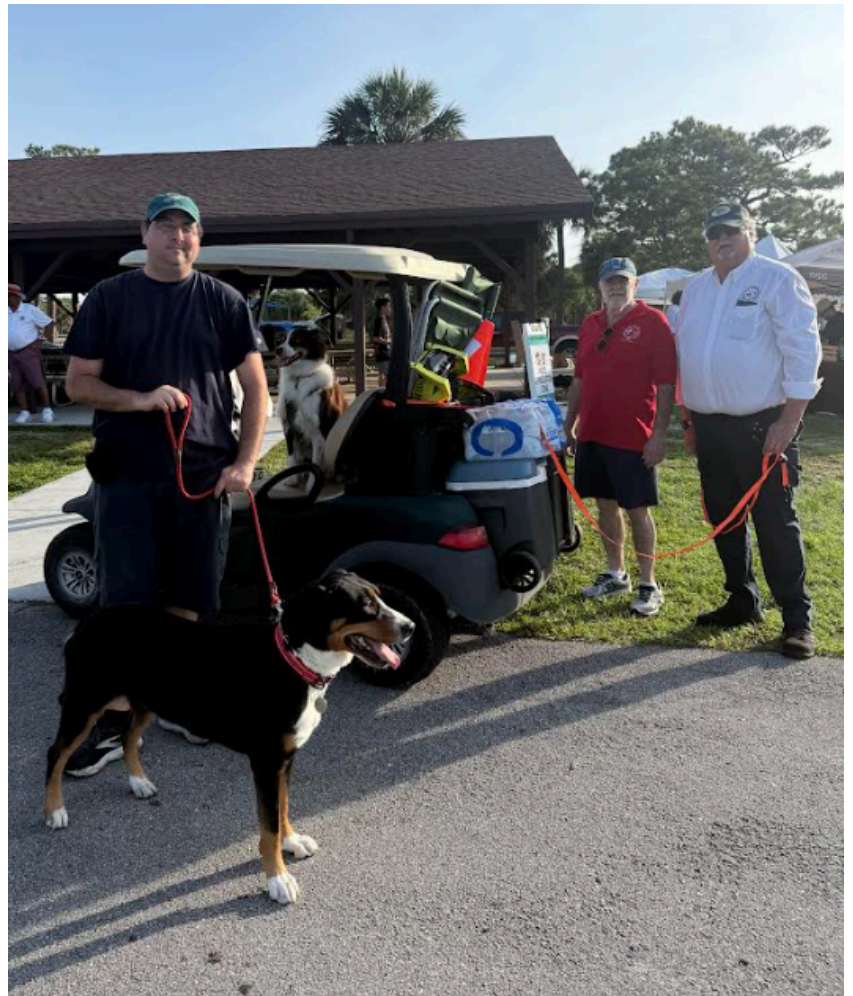

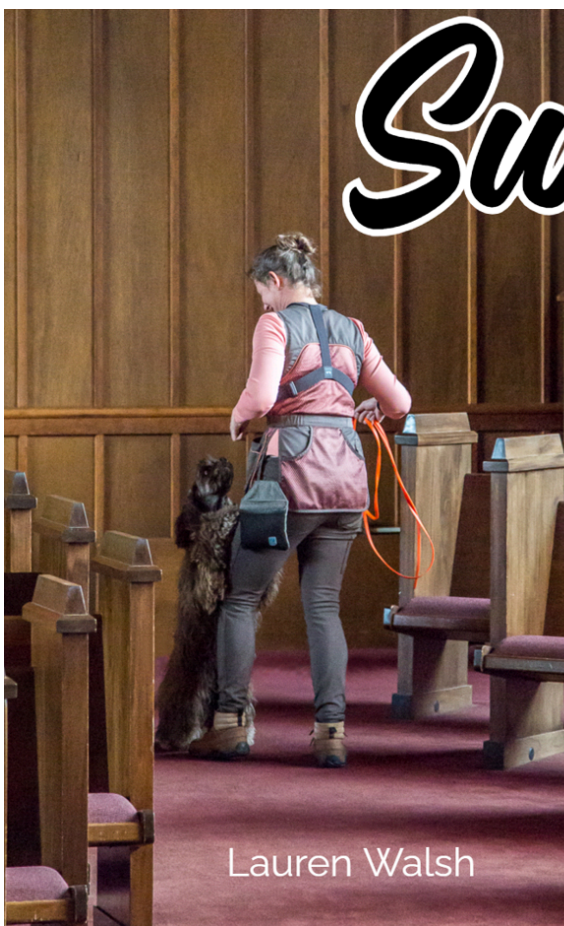

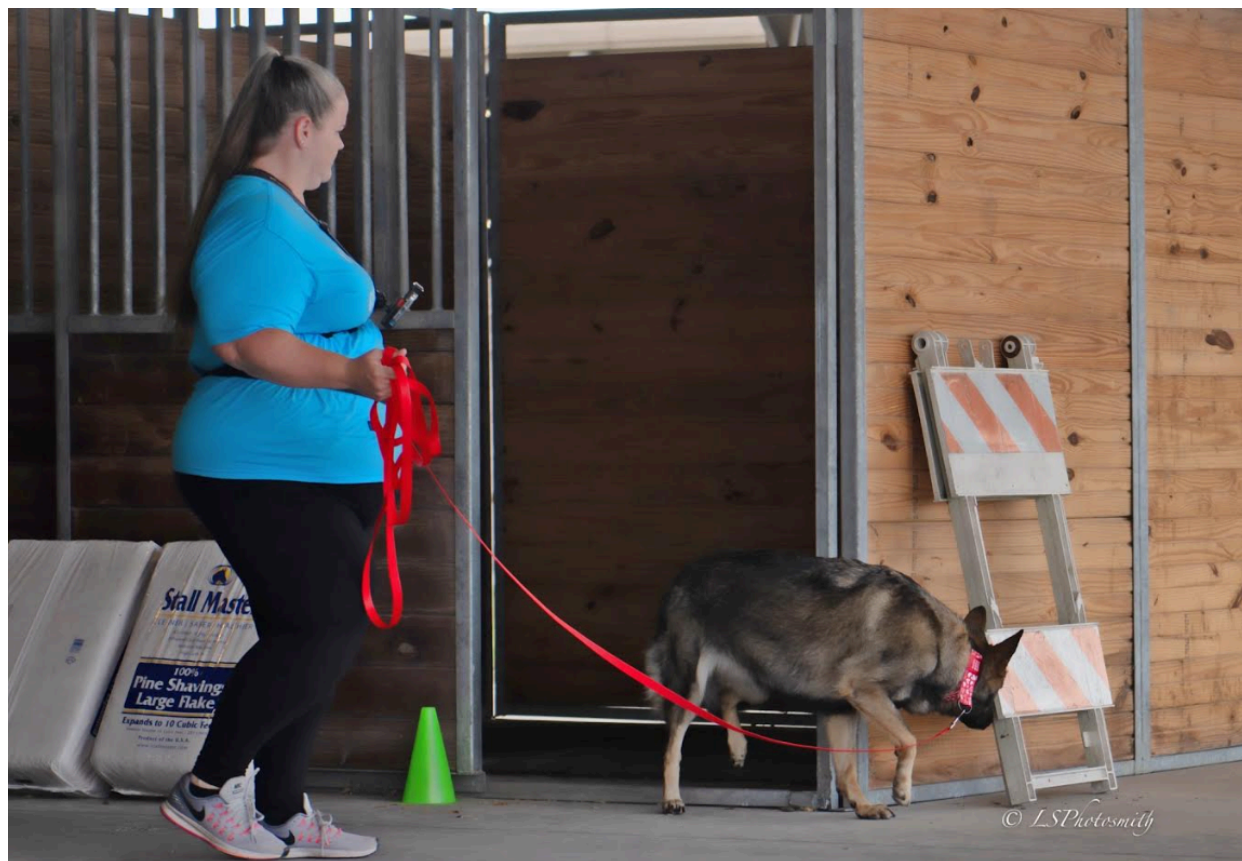

Aries and I competed at our FIRST National Association of Canine Scent Work Trial at St. Lucie Fairgrounds in Ft Pierce.

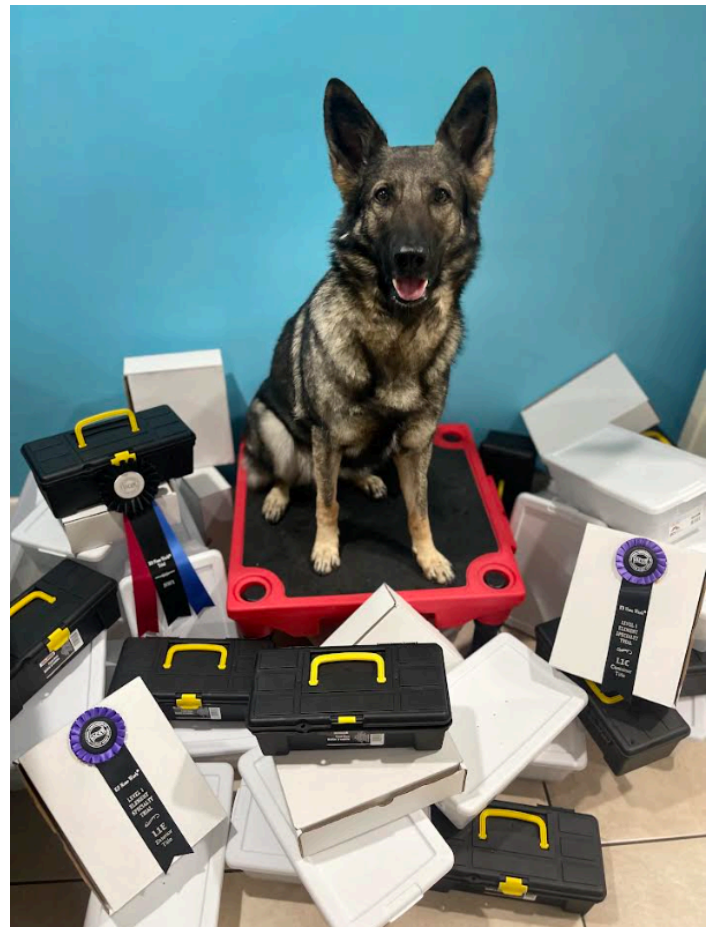
Saturday was a half day and she earned a Level 1 Element Specialty title in Exteriors.
