July Meeting Minutes for OTCPBC BOARD MEETING (07/07/2025)

Zoom meeting only

Attended:

President: Betty Gansky, Vice-President: Lodge Weber, Secretary: Kelly McDonough, Treasurer: Fran Smith, Board Members: Scott Adams, June Feigenblatt & Tracey Guziejka.

Boys and Girls Club Update

Kelly updated the group on recent activities and future plans. The cereal drive for the Boys and Girls Club resulted in about 40 boxes donated, which Kelly considers a decent outcome given the restart of the initiative. Regarding potential aid for the Texas flood zone, Kelly suggested waiting for the situation to stabilize before taking action, as it's still in the recovery phase.

RDO Day Preparation Planning

The board discussed preparations for RDO Day on September 20th, including the need for volunteers and a budget approval. Betty suggested getting a smaller banner for outdoor events, as the current one is too large. Kelly offered to get quotes for a new banner suitable for outdoor use. The group also considered placing a small banner in front of their building for RDO Day to help visitors find the correct location, as there's confusion with another nearby address.

Gift Recognition

The board also decided to purchase a \$250 Visa gift card for Carol Ann Klein, who has frequently judged for the club without charge. Lodge volunteered to buy the gift card using his credit card and present it to Carol Ann at an upcoming rally trial where she will be judging.

Upgrading Thermostats for Remote Control & Air Filter Updates

Betty proposed replacing all the thermostats with a new Honeywell system for \$1,200, which can be controlled remotely via Wi-Fi. The current system has been problematic, with different thermostats behaving inconsistently during recent events. The new system can be programmed to automatically adjust temperatures at specific times and can be overridden remotely when needed. Scott explained that the building needs to be cooled early in the morning during hot months to maintain a comfortable temperature throughout the day. Agreed to replace all four at a cost of \$1,200, which includes installation and setup. North County Cooling will handle the installation, using Honeywell thermostats as recommended by their boss. The discussion then shifted to air filter maintenance, with Betty explaining that one filter in the crate room is currently inaccessible due to a pipe blocking access. North County is working on finding a solution, possibly involving a special filter that can be placed in the vent.

ShowNGo

Entries for an upcoming August trial or show-and-go event are temporarily closed while Judy updates the system to allow for two runs in the same class.

Club Social Media and Supplies

Kelly informed the board that the club's Facebook page was deleted due to inactivity and proposes recreating it along with starting Instagram and X (formerly Twitter) accounts. She suggests allowing people to post, subject to admin approval. The board discusses the pros and cons, and ultimately approves the motion to restart social media presence for the club. The discussion then shifts to ordering AKC materials such as flyers and forms for star puppy, CGC, and CGCA programs. Lodge provided pricing information, and the board decides to check existing inventory before placing an order. Betty asks Lodge to review the club's current stock during the upcoming show and go event.

AKC Volunteer Bonus Policy Update

The group discussed a motion passed in December 2023 that awards a \$100 bonus to members who volunteer 60 hours or more at AKC events in a calendar year. Lodge planned to include this in the updated bylaws and policies. Betty clarified that for agility trials, volunteers can choose between logging hours or receiving \$2 coupons for future entries, with most opting for coupons. Judy confirmed that the few volunteers who choose hours are included in the records she provides to Lodge.

Club Bylaws and Constitution Update

The committee discussed updating the club's bylaws and Constitution. Lodge plans to have a meeting in August to review these documents. Fran expressed concern about the timing, particularly for Constitution changes that require advance notice. Lodge clarified that only the nominating committee section of the Constitution will be changed, while policy and procedures will take more time. Lodge agrees to check with AKC about submission deadlines. Betty suggested implementing all changes together, effective January 1st, which Lodge strongly supported. The group also confirmed that new members should receive copies of all current documents.

June Trial Rescheduling Discussion

Betty discussed the possibility of moving the June obedience trial to a date when more snowbirds are present, potentially increasing participation. However, she wanted to ensure this change doesn't interfere with the AKC Classic qualification cutoff date in June or other club events. Betty is awaiting information from AKC contacts and will inform the group via email once he has more details.

Trial Costs and Financial Management

Betty raised concerns about the rising costs associated with obedience and rally trials, including AKC entry fees, treats, and rosettes. The group discussed options to manage expenses, such as discontinuing treats for obedience trials while keeping them for rally events where they make more money. They considered raising entry fees slightly but are hesitant to increase costs for exhibitors too much. The club's financial situation is discussed, highlighting recent large expenses and the need to maintain funds for future costs like a potential roof replacement. Betty also mentioned the importance of avoiding scheduling conflicts with other clubs' events to maximize entries.

Computer Lending Policy Change

The board discussed and agreed to stop lending their computer and software to Hollywood for their trials, as they have done so for the past two years. Kelly was tasked with notifying Hollywood's president, Allison Casper, about this decision.

Miscellaneous

Tommy Luke is scheduled to cut the dead vines on the fence for \$275, which Betty considers worthwhile.

Kelly informed the board that Celeste Platt has volunteered to coordinate membership renewals starting in October, and the board approves this assistance.

July Meeting Minutes for OTCPBC GENERAL MEMBERSHIP MEETING (07/07/2025)

Zoom meeting only.

Attended:

Meeting called to order at 7:07pm:

Betty started the meeting by calling for acceptance of April's general membership meeting minutes as distributed via email on July 6, 2025. Fran made the motion to accept the minutes, which Scott seconded Passed.

Betty reported on recent club activities and finances, highlighting the installation of new Honeywell thermostats and detailing income from various trials held since April. She mentioned significant recent expenses, including air conditioners, insurance, and building maintenance. Betty also requested donations for high combined and trial prizes, while Lodge recognized the top volunteers for 2024, and announced a \$100 reward for those who accumulated over 60 volunteer hours at AKC events. The board expresses gratitude for the volunteers' contributions, emphasizing their importance to the club's success.

June Feigenblatt, the trial chair for the November obedience trial, requested volunteers for check-in and hospitality. Betty offered to help with hospitality and suggests coordinating with Karen Jones. Storey Wenger volunteered for check-in via chat. Lodge reported on upcoming rally events, including a show and go this weekend and four trials at the end of the month. Also discussed potential volunteers, including Randy Keene and Karen Ladd, with Betty emphasizing the importance of reaching out to newer members who may be hesitant to volunteer but often become valuable contributors.

Fran presented the club's financial status and the building's value was also discussed, with estimates ranging from \$850,000 (according to the Palm Beach County property appraiser) to over \$1 million. Fran noted that despite recent expenses, the club is showing a profit for the year. She also reminds members that the club is classified as a

501(c)(7) social club for IRS purposes and emphasizes the importance of fun activities in contributing to the club's success.

Frans reflected on the club's history, noting its growth from a small group training at the armory to its current state with a valuable property and diverse activities. She emphasized the importance of volunteerism, reporting nearly 4,000 volunteer hours from 71 members in the past year, and encourages members to step up for leadership roles. Betty shared the story of Buzz Taylor's unexpected bequest, which enabled the club to purchase its current building. Celeste added that Buzz always believed the club should have its own building, and Betty described the process of acquiring and renovating the property, highlighting the dramatic transformation from its original state.

Betty reported on the club's financial success, noting the substantial increase in the bank over her 11-year presidency. She requested volunteers for the Fort Pierce trial, with Susan Minix and Lynn Brady offering to help. Judy presented registration data for various dog training classes, comparing the first two quarters of 2025 to previous years, showing a slight decline in overall registrations.

The club discussed potential marketing strategies, including advertising at a local dog-friendly brewery, but concerns are raised about the necessity and effectiveness of additional advertising given that most classes are already full. Members debated whether the lower registration numbers are due to seasonal fluctuations or if there's a need to increase class offerings, with some pointing out that the club has limited capacity to add more classes.

Members expressed concerns about balancing the need for new classes to attract younger members with maintaining time for existing members to train. Susan Minix offered to teach early morning classes to accommodate more people. Betty reviewed the current schedule, noting limited availability during peak hours. June pointed out that they are already offering duplicate classes at different times to accommodate various schedules. The group agrees on the importance of bringing in new members for the club's future.

Storey Wenger suggested improving their social media presence to attract younger people, and Kelly confirmed plans to restart their Facebook page and expand to other platforms.

The club discussed plans for a Responsible Dog Ownership Day event on September 20th. Susan Minix outlined various activities planned, including demonstrations of dog sports, microchipping, and a blessing of the animals. The group debates whether to allow outside dogs at the event, with concerns raised about safety and liability. The board will make the final decision on event details, including whether to allow outside dogs and how to manage registration if they do.



IN MEMORY





There are sounds we hear every day that we pay no attention to. The sounds of birds chirping, the sound a light breeze makes as it goes through the trees, the sound an animal makes as they breathe. There are also sounds that mean something to us, a siren indicating an emergency vehicle might be approaching, the coffee pot in the morning making that magic elixir we all crave and the sound a doorbell makes indicates we may have a visitor.

We hear the sounds our friends make when they clap and cheer because we just qualified, placed or earned a title with our dog that we have worked so hard for. The sound of our companion's tail hitting an object as they wag it so very hard, their high-pitched bark indicating they want our attention or to get them something. The pitter-patter of their feet as they quickly walk past you just close enough so you hear them, but quickly enough that you chase them to their favorite spot because they have something they shouldn't.

Then one day there is silence. We discover that silence is the loudest sound of all and we can't get the silence out of our heads. We think we hear those familiar sounds and quickly look around, hoping to see our best friend, but no one is there. The ball lays silently on the floor never moving, our training bag gathers dust, the travel crate is folded up in the corner of the room. We keep hoping that those sounds return...... but the silence persists. We long for the day that some of the familiar sounds return. A high-pitched yelp or bark, the ball comes alive again, the biscuit jar is full and the top rattles as we open it, a bark at the back door to let you know they are ready to come in, we hope for a new partner.

We give our hearts to our dogs, and they do the same for us. A bond is created that most people do not understand or have the pleasure of experiencing. There is a trust that we share with our dog, that is only understood by the two of you. The day the silence comes is the most difficult day we experience, but when the sounds return, we come back to life. Enjoy the happy sounds for as long as you can, because the silence will eventually come.

Transferable Skills Across AKC Venues

When OTCPBC was founded in 1953, its primary focus was obedience, with tracking as the only additional training venue available. In 1994, the AKC introduced agility, and in 2005, Rally was added and became the next training opportunity offered by OTCPBC. Since then, the AKC has introduced many new dog sports, providing an ever-expanding variety of training options and events for dogs and handlers alike.

While each sport has its own rules and challenges, many of the foundational behaviors overlap and can give both dogs and handlers a strong head start when branching out into new activities. One of the most rewarding parts of training and competing in AKC sports is discovering how the skills learned in one venue can be applied in another.

You'll discover that many skills are transferable across AKC venues. For example, Obedience and Rally share a strong foundation of core exercises such as heeling, sits, downs, fronts, and finishes. Both also require the dog to remain focused despite distractions in the ring, such as the judge and stewards, as well as activities happening outside of the ring. In fact, Beginner Novice Obedience even incorporates Rally-style signs to help guide teams through their exercises. Handlers who begin in Obedience often find they already have the building blocks for success in Rally and vice versa.


Handler Discrimination, where the dog locates and alerts to the handler's scented article. Training in one venue naturally supports success in the other.

Obedience and Fetch, one of the newest AKC sport venues, offers yet another example. In Obedience, dogs demonstrate their retrieving skills in multiple ways: maintaining steadiness before the send in retrieve on flat, retrieve over high, directed retrieve, and scent discrimination; driving to the retrieve article on command; returning with the article to deliver to hand; and directed retrieve. These same foundational skills transfer smoothly into Fetch and Hunt Retrieve, where dogs must be steady on the line, retrieve blinds and marks, and perform multiple retrieves such as doubles and triples, all while returning to the handler and delivering to hand.

The bridge between Scent Work and Tracking is also clear. In Tracking, dogs follow a human scent path across various terrains and in Scent Work's handler discrimination exercise, dogs are asked to locate and indicate the handler's scent on an article. Both require a strong understanding of scent recognition; an understanding of scent paths, movement, and flow; and communication between the dog and handler.



Agility, Obedience, and Rally also have overlapping foundational behaviors. Examples include a strong stay to hold steady on the line, sending to jumps and obstacles, executing go outs, maintaining a strong contact with the handler, and assessing handler cues.



Of course, at the heart of every AKC venue is the unshakable bond between the dog and handler. Each training session and competition deepens that partnership, trust, teamwork, and communication. This connection is what truly makes the journey so rewarding.

No matter which AKC sport or venue you begin with, the time spent teaching your dog foundational skills is never wasted. Each new sport becomes an opportunity to build on existing skills, strengthen your bond, and enjoy new challenges together.

OTCPBC — Memories of the "Old Days."

I joined the club in the late 60s — maybe '68 or '69 — with a very unruly German Shepard named Akela. He was not the best dog for a beginner to start with in obedience. He was big and I was probably 100 lbs at the time. He lunged and tugged and dragged me all over the place. My first instructor, Mary Jane Kelley, minced no words about my future with that dog — either train him, or I was in a world of trouble, she warned. I went home that night determined to be able to handle my dog.

I stubbornly kept coming back to training and Akela became my first UD dog. I was hooked on obedience training and club activities. I was secretary of the club and Lead Lines Editor for many years and instructed classes regularly.

Training classes were held at the National Guard Armory in West Palm Beach. Some of the people I trained with were Mary Jane, with her wonderful sheltie Duffy; Vic Cobb with a top Weimaraner, Misty; Buzz Taylor with his great lab, Tar, and bassets, Autumn and Hoppy. Anyone who knew Buzz Taylor will attest to the fact that he was a definite "character." He and his dogs were well known at trials around the state. His wife Dorothy was always along to help, wearing one of her signature caps. Peggy DeMinico came along a few years later with the sweetest lab, Pearl.

Our chores for the training nights first included "set up." That meant loading up a dolly with mats and jumps from the storage room and setting up rings for open and utility. At the end of the evening, we had to roll the mats back up, and put all the jumps and equipment away. We took turns instructing beginner's classes in the parking lot and did "run throughs" and training for members who were trialing inside the building.

Wayne Smith was always around to help, along with other club members who pitched in each week with the set up and tear down work. George Jones was an early president of the club and headed up the tracking group with his Chesapeake Bay Retrievers.

Trainers in dog sports today have so many options available that it's hard to believe that back then we had no other performance sports except obedience and tracking. There were specialty breed sports such as coursing, but were not really available for most breeds. Rally and agility weren't available yet, nor any of the other performance activities that are popular today. The OTCH had not been invented, so a UD was the highest obedience accomplishment.

We kept up our interest in training by trying for placements which would earn points for national ranking for our breed. The obedience publication, Front and Finish, kept tabs on placements at shows and announced the top ten competition dogs for each breed at the end of the year. Popular breeds at that time in obedience included German Shepherds, Dobes, labs and shelties. Border Collies and Goldens were not yet as predominant as they are today.

We trained hard and there was a great deal of camaraderie at trials where club members rooted for each other. Buzz had a set of practice jumps that he took to trials. We set them up in parking lots or an area adjacent to the motel we were staying, and we would train after a trial. I remember many trials at which Buzz, Mary Jane and Vic would be juggled around in the first three places. They were very dominant competitors throughout the state.

Most of my training, trialing and club involvement was in the 1970s. It was all-consuming at that time, training beginners classes Tuesdays at the Armory, and in a parking lot in Riviera Beach on Thursdays, plus club work as Secretary

and collecting news from members for Lead Lines. I have fond memories of going to shows and trials. Some of us competed in conformation and obedience — I mainly competed in obedience, but my Weimaraner "Travis" and Schipperke "Bear" had titles "at both ends."

Club members today are so lucky to have the beautiful training facility, largely thanks to the generosity of Buzz and Dorothy Taylor. No more rolling out mats and putting them away each training session.

My training and trialing activities are much reduced nowadays, but I still enjoy going to Scent Work classes with my Lowchen, Rocko.

Thank you OTCPBC for years of fun and companionship. Enjoy being involved in your club and enjoy your new building and all the new performance sports!
