#### **ELIGIBILITY**

**ELIGIBILITY FOR TDX TEST:** Only dogs that have earned a TD or a TDU title are eligible to be entered in a Tracking Dog Excellent test. Dogs that have been listed with AKC Canine Partners, that have been spayed or neutered, may participate providing their listing number has been listed on the entry form and the test-giving club is holding an all-breed test and is offering participation for dogs enrolled in the AKC Canine Partners program.

**BITCHES IN SEASON MAY PARTICIPATE:** Entrants must notify the Test Secretary and Judges that their Bitch is in season prior to the drawing for tracks. Bitches in season will participate only after all other dogs have been run.
