Only ACT entry forms will be accepted and must include the exhibitors signature. **Inquiries may be directed to Rachel Beene YGtrialssec@gmail.com.** No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance.

Telephone, email and fax entries cannot be accepted. Entries not on Official AKC ACT Entry Forms or Entry forms without the Agreement and Rules on the reverse side of the form are not acceptable. Unsigned Entry Forms cannot be accepted nor entries which specify any conditions as to its acceptance. Entry Forms MUST be filled out completely. Incomplete entries do not constitute a valid entry.

Owners are responsible for errors in making out entry forms, whoever may make such errors, & no entry will be refunded in event of such errors or cancellation of entries after published closing date. Illegible entries will not be processed. PLEASE PRINT OR TYPE CLEARLY. **NO STAPLES OR TAPE PLEASE.**

Returned checks do not constitute a valid entry and **OTCPBC** will add a **\$35** collection fee to the amount of each returned check. Overpayment of \$10 or less will not be refunded.

**REFUNDS:** There will be no refund for injury or illness after entries close. **No entry fee** will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, an act of God, public emergency, act of public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused or barred from competition by the action of the Trial Committee.

## HEIGHT DIVISIONS

## MEASURING and HEIGHT CARD INFORMATION

In the AKC ACT program, owners/agents may register their dogs for any jump height. All height divisions will be offered in both Standard and Jumpers ACT1 and ACT2. 4", 8", 12", 16", 20", 24" are all acceptable Height. If you are unsure of your dogs jump height, please ask a Sailfish Club Member for help with measurement.

## DOGS ELIGIBLE TO ENTER

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds. **Dogs that are not AKC registered/listed may be registered at a later date and receive their ACT title at that time**

**MIXED BREEDS:** All mixed breed dogs are welcome to participate in the AKC ACT program. Under "Breed" on the entry form, dogs must be listed as "All American" and not as a breed hybrid. If you would like to register your dog with AKC, we will be able to assist you with on-line registration at the event.

Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under four (4) months of age are strictly prohibited from the trial grounds.

## COURSE FAMILIARIZATION AND WARM-UPS

Paper course maps will be available with description of obstacles. Walk thrus will be at Judges discretion

## AWARD INFORMATION

Placement Ribbons will be given for 1st through 4th place in each jump height in each class. Ribbons will be awarded to all dogs receiving a qualifying score. All prizes must be claimed the day of the trial—none will be mailed.

IF IT IS NECESSARY TO RESCUE A DOG from a parked car on the show grounds, the Club will not be responsible or liable for any damage to the car involved.

Owners or handlers entering dogs in a trial do so at their own risk and agree to assume responsibility for any damage caused by them, or by their dogs. They also agree to abide by the Rules of the American Kennel Club and the current edition of the AKC Agility Regulations.

The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all the obstacles safely.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such cases, no refund of any fees paid will be made.

Anyone in violation of a restriction pursuant to AKC rules or policies, or the law can be asked to leave the grounds. If the person fails to leave, the local authorities will be contacted. In addition, if the club believes laws, restrictions, or conditions of release are being violated by an individual's attendance or participation in AKC events, the local authorities will be contacted immediately as they have the authority of enforcement.

## FEO & FIX N GO

### Entering For Exhibition Only (FEO)

- For Exhibition Only may be offered at the option of the host club. FEO will allow exhibitors to work with their dogs in a trial environment. FEO is allowed in all classes. Participation in FEO is non-qualifying.
- FEO runs are treated as trial entries. The exhibitor must enter the class(es) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- Dogs may be entered at any level (Novice, Open Excellent or Masters) in FAST, JWW, Standard or Premier classes. If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out to the scribe and the judge.
- Course time for FEO in Time 2 Beat, JWW, Standard, Premier and ISC will be 45 seconds. FAST courses times for each class/height are as noted in the Regulations.

## Fix and Go On

FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score. Fix and Go On is not pre-entered; rather, it occurs during the run.

## OBSTACLE, RING CONDITIONS, and SITE INFORMATION

Obstacles will meet the specifications for obstacles in the current edition of the Regulations for Agility Trials. All classes will take place outdoors, under a covered arena, on clay/dirt surface. Ring size is a minimum of **100' x 100'**. Electronic timing will be used. Contacts are rubberized.

**Crating Space:** There is ample crating space under cover. Crates may be left overnight, but exhibitors do so at their own risk. No crating on arena floor. Vendor spots will be marked, do not crate where a vendor will be set-up.

# AKC ACT TEST

## Agility Titling for Beginner Dogs and Handlers

The Agility Course Test (ACT) is an entry level agility event designed to introduce and welcome all breeds of beginner dogs and handlers to the world of AKC Agility! You will learn the skills required for competing at AKC events. Filling out entry forms, checking in at the gate, take their dog in and out of ring, handle their dog while being judged, worker spots and much more!! And you get to have fun with your best furry friend!

**Dogs must be 15 months or older and already training in agility.**

**This is not a try it out event.**

**The dog cannot have achieved any AKC Agility title**

**There are 4 levels of ACT Events:**

- ACT 1 (Standard) & ACT 1J (Jumpers)

Courses are designed for the beginner level dog to show beginner sequencing and performance skills.

- ACT 2 (Standard) & ACT 2J (Jumpers)

Requires an increased skill level shown by the additional obstacles to be performed.

**You do NOT have to title in ACT 1 or ACT 1J to enter ACT 2 & ACT 2J.**

**Competitors can run both in one day.**

## **How to Achieve an ACT Title**

- Run a course at any height
- 2 qualifying scores
- Minimum allowable score required to qualify = 85

### **STANDARD ACT1-**

10-12 obstacles

Time for all jump heights is 60 seconds

Allowed: Bar Jump, Panel Jump, Tire Jump,

Required: A Frame; Pause Table; Open Tunnel; One Bar Jump

### **STANDARD ACT2-**

11-13 obstacles

Time for all jump heights is 70 seconds

Allowed: Bar Jump, Panel Jump, Dog Walk, Double Bar Jump, Broad Jump, Triple Bar Jump, Ascending Double Bar Jump

Required: A Frame; Pause Table; Open Tunnel; One Bar Jump, SeeSaw, Weave Poles (6), Tire Jump

### **JUMPERS ACT1J- (Jumpers)**

10-12 obstacles

Time for all jump heights is 50 seconds

Allowed: Open Tunnel, Bar Jump, Panel Jump, Tire Jump, Required: One Bar Jump

### **ACT2J- (Jumpers)**

11-13 obstacles

Time for all jump heights is 60 seconds

Allowed: Open Tunnel, Bar Jump, Double Bar Jump, Panel Jump, Tire Jump, Broad Jump, Triple Bar Jump Required: One Bar Jump, 6 Weave Poles

- Refusals & Run-outs are not judged.
- More than 3 attempts at an obstacle will result in an elimination (failure).
- The rest of the faults are the same as in the regular agility classes

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents, event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge or ACT Evaluator, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. Dogs may be entered in any jump height. There is no Regular or Preferred distinction at AKC's ACT events.

In order to acquire the ACT1 or ACT2 title certificate and have the title added to a dog's record, the dog must be registered/listed with the American Kennel Club. **AKC Canine Partners<sup>SM</sup>** applications may be accepted at the event and submitted to AKC with the event's results.

Dogs that are not AKC registered/listed may be registered at a later date and receive their ACT title at that time.

Dogs listed in the **AKC Canine Partners<sup>SM</sup>** program should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

**Junior Handlers** should enter their Junior Handler Number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
